Sales Comparison Analysis

For the valuation of the Subject Property, we have concentrated properties with similar current Highest and Best Uses as the Subject Property. We analyzed the Subject Property based on the price per lot as this is the most recognized unit of comparison in this market. Per analysis of the Subject's market area, we noted that the overall market for single family homes is stable, however, we noted significant increases in vacant land sales. All of the comparables were considered with regard to property rights appraised, time or market conditions, location, size, access, site quality, and zoning. The Subject Property is located on a 14,547-sf site with a drainage easement located on the western borderline of the property. We have provided Comparable 2 and Listing 4 which have similar drainage easements. Comparable 3 was adjusted upward for inferior site size. The comparable sales indicate an adjusted range from \$148,000 to \$153,000 and are considered to be good indicators of market value. In our value conclusion we considered the Subject's site size, views and overall location. We considered Comparable 2 to be the best sale at the time of inspection. Therefore, we concluded at the middle range of adjusted values and concluded \$150,000 or \$10.30 per square foot as it is well supported by the adjusted and unadjusted sales prices of the comparable sales.


