**EIGHTH AMENDMENT TO INTERLOCAL AGREEMENT
(TRAFFIC CONTROL AND SECURITY -
ST. LUCIE COUNTY SPORTS COMPLEX)**

THIS EIGHTH AMENDMENT TO INTERLOCAL AGREEMENT by and between **ST. LUCIE COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as "County," and the **CITY OF PORT ST. LUCIE**, a Florida municipal corporation, hereinafter referred to as "City."

W I T N E S S E T H:

WHEREAS, on June 21, 1988, the parties entered into an Interlocal Agreement, hereinafter referred to as the "Agreement," which was recorded in Official Records Book 593, pages 1800 through 1802, of the public records of St. Lucie County, Florida, which provided for the City to furnish off-duty City police officers to the County to perform traffic control and security during scheduled events at the St. Lucie County Sports Complex.

WHEREAS, the parties subsequently amended the Agreement on June 20, 1989, May 19, 1998, March 24, 2000, May 10, 2000, January 1, 2002, December 16, 2005 and January 1, 2008 to reflect increases in the hourly wages paid to the City's police officers and supervisors, and apply a 3-hour minimum for each officer, which amendments were recorded in Official Records Book 644 at page 321, Official Records Book 1155 at page 2201, Official Records Book 1287 at page 2865, Official Records Book 1301 at page 1179, Official Records Book 1484 at page 807, Official Records Book 2440 at page 604 and Official Records Book 2963 at page 1600 of the public records of St. Lucie County, Florida, respectively; and,

WHEREAS, the City intends to further increase the hourly wage paid to its police officers and supervisors effective March 1, 2009; and,

WHEREAS, the parties desire to further amend the Agreement to reflect the planned increase in the hourly wage for the City's police officers and supervisors.

NOW, THEREFORE, in consideration of the premises and undertakings contained herein,

the parties hereto agree to amend the Agreement as follows:

1. Paragraph 3 shall be amended to read as follows:
 3. In return for the faithful performance of the services provided in accordance with the terms and conditions of this Agreement, the County agrees to pay to the City thirty-two and 00/100 (\$32.00) dollars for each hour of service provided to the County by a police officer ($\$32.00 \times 3\text{-hour minimum} = \96.00) and 00/100 and thirty-five and 00/100 (\$35.00) dollars for each hour of service provided to the County by a police supervisor ($35.00 \times 3\text{-hour minimum} = \105.00). The rates set forth herein include a two (\$2.00) dollar per hour administrative fee.
2. The rate increase provided herein shall be effective March 1, 2009.
3. All other terms and conditions of the Agreement, as amended, remain in full force and effect.

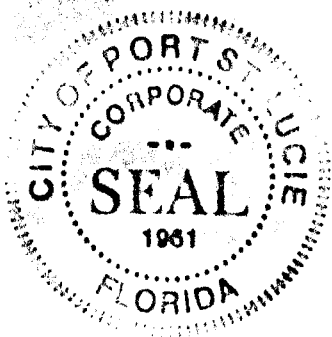
