regarding your complaint: On 4/29/2024 a Notice of NonCompliance was sent to the contractor regarding expired permit for a
boat lift at 162 NE Surfside Ave with a compliance date of 5/30/2024. Compliance was not
obtained. On 1/24/2025 Permitting Manager, Beth Barense, spoke with the contractor and
advised them of verbal complaints received from residents regarding expired permits and
incomplete inspections. At that time the contractor requested information regarding a list of
permits to be addressed. A list of issued, expired, and abandoned permits was sent to the
contractor that same day. On 2/27/2025 another Notice of NonCompliance was sent to the
contractor regarding the additional expired/abandoned permits on record with a compliance
date of 3/12/2025. As of todays date of 5/2/2025, building department records show only one
permit that has been addressed by the contractor (#2150525) which was completed on
3/10/2025.
