- 1. Additional renovations to the Report Room as requested by the City.
 - Scope of Work includes the following:
 - Demolition:
 - Removal of existing ceiling grid and tiles
 - Removal of existing light fixtures
 - Removal of existing supply & return grilles
 - Painting:
 - Painting of interior walls, doors and door frames
 - Flooring:
 - INCLUDED IN ORIGINAL PROJECT
 - Acoustical ceiling tile & grid:
 - Supply & install Rockfon Tropic #1000 24"x24" Tile and Grid
 - Electrical:
 - Supply & install new 2'x4' standard lay-in tied to the deck per design drawings
 - HVAC:
 - Supply & install new air distribution, and new flex duct as required. Comfort balance included.
 - Drywall:
 - Misc. patching as needed
 - Disposal of all removed materials
 - Protection of existing floors as needed
 - Proposal excludes the following / assumes the following to be by others:
 - Any work not outlined in the inclusions
 - Owner to remove everything from the walls, floors, and all other work surfaces prior to work commencing
 - Any low voltage / IT work
 - Any and all hidden conditions
 - All permits and all permit fees
 - Premium time related to an accelerated schedule or afterhours work
 - Abatement or removal of any and/or all hazardous materials such as materials containing asbestos or lead paint
 - All work associated with any scopes not noted as included
 - Please note the following:
 - Schedule assumes that Hedrick Brothers will be uninterrupted by owner and vendors outside of Hedrick Brothers control
