**6.c** Saints Quarterly Report - FY 24/25 Annual Report

(Clerk's Note: A PowerPoint presentation was shown at this time.) Keith Bradshaw, Saints Golf Course Administrator discussed the highlights of the year, noting that it was a record year for the Saints Golf Course. He discussed topics for projects including art path repair, driving range hitting area enhancements, pump house upgrades, addition of sub-surface drainage, bunker upgrades, and new drainage systems. He then discussed the Golf Market for FY24/25 including data & statistics, women's growing influence on golf, and FY24/25 visitation. The Committee and Mr. Bradshaw held a discussion on potentially opening another golf course in the future on the west side of the City due to the success of The Saints.

Mr. Bradshaw continued discussion on visitation and noted that they now have more youth playing at the golf course. He then discussed the FY24/25 financials, and the Committee and Mr. Bradshaw discussed the impact of the restaurant located within the Saints, ways to increase revenue, and resident vs. non-resident members.

Mr. Bradshaw continued with monthly revenues, driving range annual revenues, financial forecast, operation performance, and plans & goals. Staff and Mr. Bradshaw then discussed naming rights for a new property, and an indoor golf simulator. The Committee recommended holding a meeting at the Saints Golf Course at least once a year.

7. Unfinished Business

Charlie Proulx reiterated that they have a new schedule and new projects to discuss, and that the Cost Analysis project has been temporarily tabled.

Vice Chair Bernard reminded that there are elections in January.

8. Adjourn

There being no further discussion, Vice Chair Bernard moved to adjourn the meeting. Mr. Williams seconded the motion, which passed unanimously by voice vote. The meeting was adjourned at 2:52 p.m.
