Purpose

The purpose of the appraisal is to develop an opinion of market value of the Subject Property as defined in this report (see limiting conditions attached for definition).

Intended Use

This report was prepared for our client, City of Port St. Lucie. The intended use of this appraisal is to assist the client mentioned in this report in evaluation of the Subject Property for land valuation of 150 SE Fiore Bello, Port Saint Lucie, FL. 34952. The scope of work performed is specific to the needs of the intended user and the intended use. No other use is intended and the scope of work may not be appropriate for other use.

Scope of Work

Subject Property Identification:

Danielle M Crowe has viewed readily accessible areas of the lot, and has viewed the property solely for valuation purposes and to observe property characteristics that a typical purchaser would consider in their decision making process, as well as those items outlined in the assumptions and limited conditions and certification to this appraisal. Personal property was not included in the appraised value.

Sources of Information:

The appraisal is based on the information gathered from public records; viewing of the Subject Property, neighborhood and comparable properties; and other sources specifically identified in this report. When conflicting information has been discovered, the sources deemed most reliable have been used.

The Subject Property is situated on SE Fiore Bello, and it is situated on a interior lot with views of a community lake. No adverse, or positive affect on value or marketability as a result.

Neighborhood Comments

Subject Property is located in SE Port St Lucie, east of the Florida Turnpike, in a predominately residential neighborhood consisting of mostly single family homes. SE Westmoreland Blvd, a local traffic artery, is within 1 mile, and offers access to shopping, schools, employment centers, and freeways.

Highest and Best Use Analysis Summary:

We have concluded the highest and best use of the property is for future development of a Single Family Residence as it is the only legal use of the property.

Sales Comparison Analysis

Comparable 1 was considered as it is a recently closed sale that is similar in zoning and is located on the same street as the Subject Property. This site sold slightly higher than the other sites as it has a \$10,000 builder's royalty that was paid.

Comparables 2 and 3 were considered as they are both bracket site size, views and access. Upward adjustments were made for site size.

Comparable 4 was also considered as it is similar in site size.

Comments on Sales Comparison

For the valuation of the Subject Property we have concentrated properties with similar current Highest and Best Uses as the

Subject Property. We analyzed the Subject Property base on the sales comparison approach as this is the most recognized unit of comparison in this market. All of the comparables were considered with regard to property rights appraised, time or market conditions, location, size, access, site quality, and zoning. The four comparable sales indicated a non adjusted range from \$105,000 to \$130,000. In our concluded value, we gave most consideration to Comparables 2, 3 and 4 as they are similar in views and Comparable 4 is similar in site size. Therefore, the concluded value of \$110,000 is well supported by the unadjusted sales prices of the comparable sales

Prior Sales Comments

To the best of our knowledge, the above stated data is believed to be accurate. Said findings are based on a search of Public Records and MLS. We are not title agents nor Real Estate Attorneys and does not have the extensive research and document search tools that the aforementioned have. If a more precise, in depth search is desired, we recommend a through search by a qualified underwriter, Real Estate Attorney and/or title agent. There was a County Deed for the Subject Property and three other properties issued on the above referenced date, as well as on 07/25/2019 an Escheatment Tax Deed was issued.

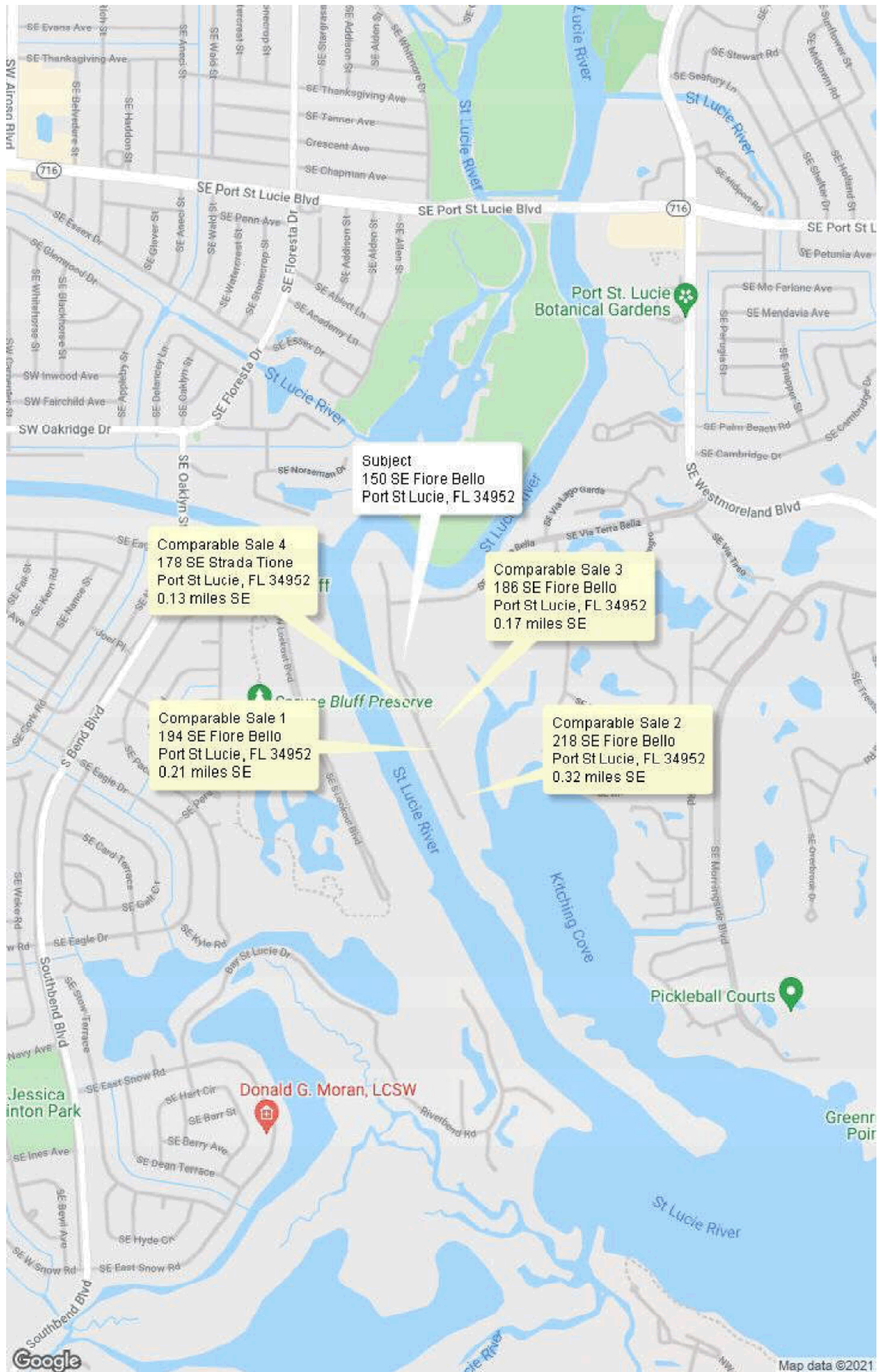

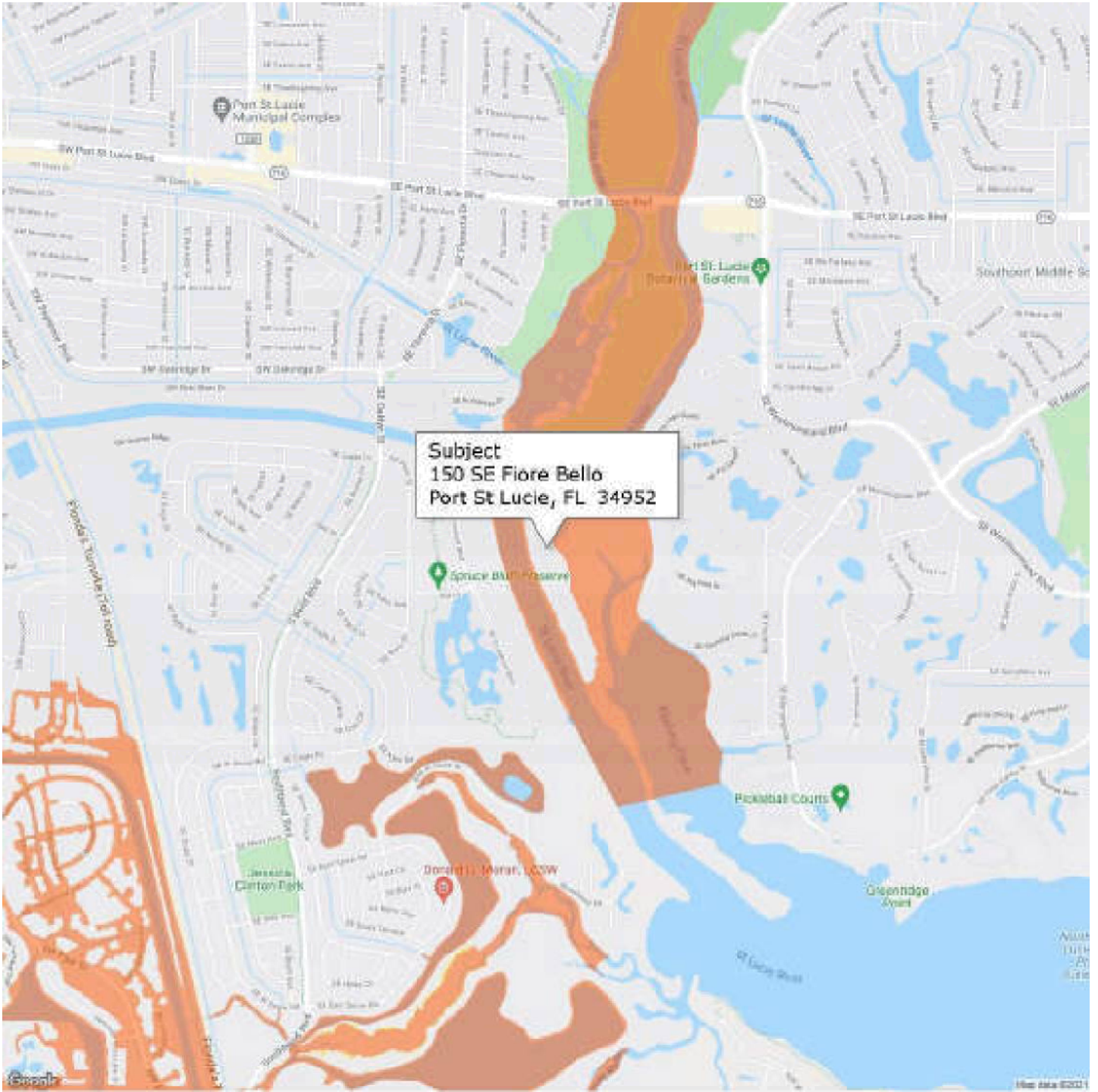
