AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, PROVIDING FOR THE THIRD AMENDMENT OF THE PLANNED UNIT DEVELOPMENT DOCUMENT AND CONCEPTUAL MASTER PLAN FOR VERANO SOUTH POD D PLANNED UNIT DEVELOPMENT (P20-214) LOCATED SOUTH OF THE C-24 CANAL, AND NORTH OF CROSSTOWN PARKWAY AND WITHIN THE VERANO DRI; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Cotleur & Hearing, (the "Applicant") seeks to amend the Verano South Pod D Planned Unit Development (PUD) and Conceptual Master Plan (P20-214); and

WHEREAS, the Verano South Pod D PUD and Conceptual Master Plan was initially approved by Ordinance 19-09, and was amended by Ordinance 20-17 and Ordinance 20-38; and

WHEREAS, the Applicant seeks to amend the Verano South Pod D PUD and Conceptual

Master Plan to add language regarding the applicability of the Citywide Design Standards; and

WHEREAS, the amendment also seeks to amend Exhibit 9.a. to modify the layout of the Pod D Conceptual Master Plan; and

WHEREAS, the proposed amendments to the Verano South Pod D PUD and Conceptual

Master Plan are attached as Exhibit "A" and incorporated herein; and

WHEREAS, the City of Port St. Lucie Planning and Zoning Board held a public hearing on January 5, 2021, to consider the amendment to the Verano South Pod D PUD and Conceptual Master Plan, notice of said hearing to adjoining property owners for a radius of seven hundred and fifty (750) feet having been given and advertising of the public hearing having been made; and

WHEREAS, the City Council held a public hearing on February 8, 2021, to consider the amendment to the Verano South Pod D PUD and Conceptual Master Plan, advertising of the public hearing having been made; and

ORDINANCE 21-

WHEREAS, after review of the recommendations of the City staff, the Planning and Zoning Board, comments made at the public hearing, and careful consideration of the issues and evidence, finds that the proposed amendments to the Planned Unit Development Document and Conceptual Master Plan are consistent with Article of X Chapter 158 of Title XV of the Port St. Lucie City Code.

NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

<u>Section 1</u>. <u>Ratifications of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a port of this Ordinance.

Section 2. That the Verano South Pod D PUD and Conceptual Master Plan as approved by Ordinance 20-38 of the City of Port St. Lucie, are amended as reflected in the Planned Unit Development Document labeled Exhibit "A" and attached hereto.

Section 3. Conflict. If any ordinances, or parts of ordinances are in conflict herewith, this Ordinance shall control to the extent of conflicting provisions. The provisions of Ordinances 19-09, 20-17, and 20-38 of the City of Port St. Lucie, not inconsistent with the provisions of Section 2 herein shall remain in full force and effect.

Section 4. Severability. The provisions of this Ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid or unconstitutional by a Court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.
