A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, APPROVING AND ACCEPTING THE PRELIMINARY PLAT AND CONSTRUCTION PLANS FOR DEL WEBB AT TRADITION PLAT NO. 5A (P21-016) WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA, ON THE REQUEST OF PULTE HOME COMPANY, LLC; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City of Port St. Lucie, Florida has been requested by Pulte Home Company, LLC, the owner, to approve and accept the preliminary plat titled Del Webb at Tradition Plat No. 5A, with construction plans, within the City of Port St. Lucie, Florida; and

**WHEREAS**, there are private improvements to be constructed within the platted area by the developer; and

**WHEREAS**, the plat conforms to Section 156, Port St. Lucie City Code, and meets all State requirements for such plats; and

**WHEREAS**, the Site Plan Review Committee, on February 10, 2021, recommended approval of the preliminary plat and construction plans (P21-016).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:**

Section 1. Ratification of Recitals. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. Approval of Preliminary Plat and Construction Plans. That the City Council hereby approves the preliminary plat and construction plans titled Del Webb at Tradition Phase 5A (P21-016) within the City of Port St. Lucie, Florida, said plat being offered by Pulte Home Company, LLC, the owners, and as prepared by Caulfield and Wheeler, Inc. as designated on the attached said Plat.
