## **RESOLUTION NO. 21-**

A RESOLUTION APPROVING A PRELIMINARY AND FINAL PLAT FOR SOUTHERN GROVE PLAT NO. 38 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF CULPEPPER AND TERPENING, INC. (P21-221); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City of Port St. Lucie, Florida has been requested by Dennis Murphy, Culpepper and Terpening, Inc., acting as agent for the City of Port St. Lucie and the Port St. Lucie Governmental Finance Corporation, owners, to approve a preliminary and final plat for Southern Grove Plat No. 38, within the City of Port St. Lucie, Florida; and

**WHEREAS**, there are no public/private improvements, i.e., roads, drainage, and utility facilities, to be constructed within the platted area by the developer; and

**WHEREAS**, the plat conforms to Section 156, Port St. Lucie City Code, and meets all State requirements for such plats; and

**WHEREAS**, the Site Plan Review Committee, on October 13, 2021 recommended approval of the preliminary and final plat with construction plans (P21-060).

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. That the City Council hereby approves the preliminary and final plat for Southern Grove Plat No. 38, within the City of Port St. Lucie, Florida, said plat being offered by the City of Port St. Lucie and the Port St. Lucie Governmental Finance Corporation, as owners and title holders of said property, and as prepared by Thomas P. Kiernan, as designated on the attached said Plat.

<u>Section 3</u>. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the said plat so it may be properly recorded in the public records of St. Lucie County, Florida.

<u>Section 4.</u> Conflicts. If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.
