SUBJECT: Expenditure of Forfeiture Funds

The purpose of this memo is to request City Council to appropriate and expend forfeiture funds for FY 2526 in accordance with F.S.S. 932,7055.

The current estimated Fund 603 forfeiture expenditure request is for \$113,065. In summary, this is comprised of the following areas:

\$25,500	Allocation for forfeiture-related court costs, settlement costs, city attorney costs, etc.				
\$40,000	Allocation to purchase various equipment for the Crisis Negotiation Team.				
\$45,000	Allocation of support donations to various crime prevention				
	programs/organizations.				
\$ 2,565	Unallocated amounts for a future forfeiture request.				

The above requests are not budgeted in the General Fund. The detailed breakdown and description of qualifying expenditures is provided in the attached "Exhibit A". As required by statute, I further certify that the expenditures and appropriation requested herein comply with the provisions of s.932.7055(5), Florida Statutes.
