A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, APPROVING THE PRELIMINARY AND FINAL PLAT WITH CONSTRUCTION PLANS FOR VERANO SOUTH PUD 1- POD G- PLAT NO. 1 WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF VERANO DEVELOPMENT, LLC (P20-157); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

That the City Council hereby approves the preliminary and final plat with construction plans for Verano South PUD 1- Pod G - Plat No. 1, within the City of Port St. Lucie, Florida, said plat being offered by Verano Development, LLC, as owner, and title holder of said property and as prepared by Gary A.
