**P17-066-A1 GATLIN PLAZA – MASTER SIGN PROGRAM
AMENDMENT**

Dennis Murphy, Culpepper & Terpening, represented the applicant and stated he had no questions regarding the comments. Mr. Murphy noted that the markups were not posted in Fusion. Public Works and Utilities had no further comments to what was provided in Fusion and recommended approval with all comments to be addressed. Planner Robinson stated Planning and Zoning recommended approval with all comments to be addressed.
