# INTERLOCAL AGREEMENT COMPUTER AIDED DISPATCH, RECORDS MANAGEMENT SYSTEM, & MOBILE COMPUTER TERMINAL/MOBILE FIELD REPORTING (CAD, RMS, & MCT/MFR) SYSTEM SHARED NETWORK

this interlocal agreement") is made and entered into this 20 day of <u>February</u>, 2024, by the between ST. Lucie County, a political subdivision of the State of Florida (the "County"), the ST. Lucie County SHERIFF'S OFFICE (the "Sheriff"); the CITY OF FORT PIERCE, ("Fort Pierce"); the CITY OF PORT ST. Lucie, ("Port St. Lucie"); and the ST. Lucie County FIRE DISTRICT ("SLCFD"), an independent special district of the State of Florida. The County, Sheriff, Fort Pierce, Port St. Lucie and SLCFD may be referred to individually as an "Public Safety Agency" or collectively as the "parties."

## **RECITALS**

WHEREAS, the parties implemented a new CAD, RMS, & MCT/MFR system which consolidated and centralized the CAD, RMS & MCT/ MFR system in order to better serve the residents of the County and the cities; and,

WHEREAS, the parties determined that a shared network solution is needed for the implementation of the CAD, RMS & MCT/ MFR System Shared Network; and,

WHEREAS, the County has an Agreement with CentralSquare Technologies LLC, as successor in interest to SunGard Public Sector Inc. ("CentralSquare"), to provide support and maintenance for the County's purchased public safety software provided by CentralSquare for use by the parties at the costs detailed in Exhibit "1".

**NOW, THEREFORE,** the parties hereby agree and covenant on the terms and conditions hereinafter stated:

- 1. **RECITALS.** The foregoing recitals are hereby incorporated as forming the intent and purpose of this Agreement.
- 2. **GENERAL.** This Agreement is entered into pursuant to Section 163.01, Florida Statutes, the Florida Interlocal Cooperation Act. This Agreement embodies the whole understanding of the Public Safety Agencies. There are no promise, terms, conditions, or obligations other than those contained therein, and this Agreement shall supersede all previous telecommunications, representations, or agreement, either verbal or written, between the parties hereto.

- 3. <u>COUNTY RESPONSIBILITY.</u> This County shall be responsible for contract administration of all aspects of the CAD, RMS, & MCT/MFR software support and maintenance through the CentralSquare Software Maintenance Agreement. However, any proposed changes or amendments, including extensions, to the Agreement will be brought before the Board of Governors for consideration at a public meeting prior to implementation.
- Agency agrees to pay the County the Agency's share of the CAD, RMS, & MCT/MFR software support and maintenance within thirty (30) days of receipt of an invoice from the County for the period July 1, 2023 through September 30, 2023. The payment amounts are as set out in the attached Exhibit "1". Beginning with Fiscal Year 2023-2024 (October 1, 2023-September 30, 2024), and for the remainder of this Agreement, each Agency will receive a separate invoice detailing the amount owed and agrees to pay its share of the CAD, RMS, & MCT/MFR software support and maintenance directly to CentralSquare. Annual renewal invoices will be sent by CentralSquare and shall be received by each agency, subject to 5% increase starting October 1, 2025, as detailed in the Amendment to Software Agreement between Sungard Public Sector, Inc. and St. Lucie County (C11-06-180). The County will have no further obligation to invoice or collect payment on behalf of any other Agency.
- 5. **PARTY REPRESENTATIVES.** Each Agency shall appoint a representative to serve as a liaison in responding to matters related to the operation and maintenance of the CAD, RMS, & MCT/MFR system.
- 6. <u>CAD, RMS, & MCT/MFR SYSTEM.</u> In order to maintain the integrity of the CAD, RMS, & MCT/MFR system as a whole, the parties agree that it is critical to have all CAD, RMS, & MCT/MFR system components maintained to consistent and uniform standards.
- TERM; TERMINATION. This Agreement shall be effective on the date it is recorded in the public records of St. Lucie County, Florida, and shall remain in effect through and including September 30, 2028, unless terminated as herein provided. Upon prior written mutual agreement of the parties, the term may be extended for additional five (5) year periods. This agreement may only be terminated by mutual agreement of the parties. Notwithstanding anything to the contrary herein, the Sheriff, Fort Pierce, Port St. Lucie, and/or SLCFD may choose to opt out of this Agreement effective October 1 of any fiscal year upon providing a minimum of six (6) months prior to written notice delivered to the other parties. Upon the expiration or prior termination of this Agreement, the parties agree that each agency shall remain liable to pay any and all monies due to CentralSquare and incurred prior to said expiration or termination. Any Public Safety Agency that opts out of this Agreement pursuant to this section shall remain individually responsible for monies due and owing to CentralSquare incurred prior to opting out.
