This Amendment #16 ("Amendment #16") for the Design & Permitting for Floresta Drive Phases 2 & 3 under Contract #20190112 ("the Contract"), by and between the City and CONSOR North America, Inc. fka CONSOR Engineers, LLC fka American Consulting Engineers of Florida LLC ("Consultant"), shall be effective as of the date this Amendment #16 is fully executed.

WHEREAS, the Contract, including any previous amendments, is in effect through the Current Contract Expiration Date, as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

The following modifications to the Terms and Conditions contained in the Contract are hereby incorporated and made a part of that Contract.

1. TERMS REVISION. This Amendment #16 will increase available funds to address the replacement of aging pipelines alongside roadway construction.

- The Utility Systems Department (USD) has the opportunity to replace aging water and sewer infrastructure in coordination with the roadway and drainage improvements. While addressing the AC line replacements along Arton Lane, USD identified the need to also replace additional Water Main (WM) lines along Harbor View Lane. Completing this work now, in parallel with the roadway project, will prevent the need to return after construction is finished and will avoid subjecting residents to avoid further disruptions.
- By executing this scope in parallel with roadway activities, no extra time will be required for procurement, coordination, or planning.

2. CONTRACT PRICE INCREASE. The additional design work requires an increase in price in the amount of \$99,050.00.



This Amendment #16 and the Contract, including any written amendments thereto, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
