WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1. Additional rental of the light tower after hours for FPL meter installation. Total cost is \$815.60.
- 2. Meter can installation: Dig 24" deep trench from new transformer to the new meter can location. Install conduit and meter can. Back fill trench, sod and cover. Total cost is \$1,256.88.
- Installation of FPL feeders for the new transformer. Total cost is \$19,764.00.
- 4. Ground penetrating radar for new FPL feeder to transformer. Total cost is \$3,494.50.
- 5. Monthly charges for delays for the mini dumpster, handwash station, restroom, & temporary fencing. Total cost is \$9,529.88.
- 6. Fuel cost for main outage. Total cost is \$985.62.
- 7. Install new underground feeders for future data generator from the electric room to the generator building per BEED Engineering 's approved drawings. Total cost is \$2,102.00.
- 8. Additional generator rental fees. Total cost is \$29,752.22.
- 9. Added two (2) steel beams over main gates to carry the new louver system on the west wall. This was not part of the original contract. Shop drawings were provided for approval. Total cost is \$4,392.85.

- 10. **SUCCESSORS AND ASSIGNS.** This Amendment shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
