## **RESOLUTION 21-**

AN AMENDMENT TO RESOLUTION#21-R65 OF THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE APPROVING AN ECONOMIC DEVELOPMENT INCENTIVE PACKAGE FOR "CHENEY BROS., INC. PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Port St. Lucie, Florida (the "Council") has determined that there is a need to establish incentives to facilitate economic development opportunities within the City; and

WHEREAS, Cheney Bros., Inc. is a regional food wholesaler and distributor; and

WHEREAS, Cheney Bros., Inc. desires to relocate to Port St. Lucie, Florida; and

WHEREAS, Cheney Bros., Inc.'s average earnings of \$63,000 per worker is well above the average earnings for St. Lucie County and employees receive a generous benefits package; and

WHEREAS, Cheney Bros., Inc. intends to construct a 365,000 square foot distribution facility and will invest \$65 million in real property and \$7 million in tangible personal property capital investment; and

WHEREAS, Cheney Bros., Inc. will create 275 new full-time jobs; and

WHEREAS, the Council has considered the benefits that the citizens of the City will gain through the new regional distribution center location for Cheney Bros., Inc.'s facility to Port St. Lucie; and

WHEREAS, the City is offering a collaborative incentive package to Cheney Bros., Inc. in partnership with St. Lucie County; and

WHEREAS, the incentive package being offered and outlined below is in the best interest of the health, safety and welfare of the City's citizens.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, THAT:

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

<u>Section 2</u>. <u>Incentive Package</u>. The Council approves the following incentive package for Project Bullet:

A. The City of Port St. Lucie Ad-Valorem Tax Exemption: The Council authorizes City staff to assist Cheney Bros., Inc. in the application for a 10-year ad valorem tax exemption valued at 100% for the first five years and for the last five years on a declining percentage schedule for the remaining period (90%, 80%, 60%, 40%, 20%)

as described in the City's Economic Development Ad Valorem Tax Exemption program. The Council also authorizes staff to prepare all documents necessary to the application process, including a proposed ordinance providing an ad valorem tax exemption for Cheney Bros., Inc. consistent with the City's Economic Development Ad Valorem Tax Exemption program.

B. *Up-front Impact Fee Mitigation*: The Council authorizes staff to assist Cheney Bros., Inc. in the application for impact fee mitigation consistent with the City's Economic Development Impact Fee Mitigation Program, including a proposed Resolution waiving impact fees.

<u>Section 3.</u> <u>Conflict</u>. If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 4</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
