The purpose of this addendum is to respond to questions submitted by potential bidders for clarification of the Bid as follows:

1. Question: Can FPUA provide the name of the current Wet Lime Residuals Hauler?

Answer: Yes, the current Wet Lime Residuals Hauler is Accurate Septic Services, Inc.

2. Question: Can FPUA provide the current pricing for the Wet Lime Residual Hauling?

Answer: Yes, the current pricing for Wet Lime Residuals Hauling is \$11.00 ton.

3. Question: Can FPUA provide the current price per ton cost of dumping fees?

Answer: No, FPUA cannot provide the current cost of dumping fees, vendor is

responsible for dumping fees.

4. Question: Can FPUA provide the location of the current dumping location?

Answer: No, vendor is responsible for location of dumping.

5. Question: Does FPUA know if there are any daily restrictions known at this time at the

dumping site?

Answer: No, vendor is responsible for location of dumping.





Question: Since water treatment lime is not a required material, what specifically does

FPUA need from vendors to prove end disposal is adequate?

Answer: None, vendor is responsible for Wet Lime Residuals once it is loaded on vendor

term of the contract.

7. Question: Will the awarded vendor be required to provide equipment to remove lime

from storage areas?

Answer: No, the awarded vendor shall not be required to provide equipment to remove

lime from storage areas.

FPUA staff will pump wet lime residual into tanker.

8. Question: Will the awarded vendor only provide equipment for hauling the Wet Lime

Residuals away?

Answer: Yes, awarded vendor shall provide equipment for hauling of the wet lime

residual.

Current vendor uses a tanker truck.

9. Question: How are tankers currently loaded at the pick-up location: is it top load,

pumped into tanker by FPUA staff, or vacuumed by contractor?

Answer: Wet lime residual is currently pumped into the top of the tanker by FPUA Staff.

10. Question: Can FPUA stockpile lime on site to allow it to dewater further?

Answer: No, FPUA cannot stockpile lime on site to allow it to dewater further.

11. Question: If the Wet Lime Residual can be stockpiled for further dewatering, how much

material can be stored before it must be hauled away?

Answer: No, FPUA cannot stockpile lime on site to allow it to dewater further.

12. Question: Does FPUA require Wet Lime Residuals to be hauled away as soon as it's

removed from storage areas?

Answer: Yes, FPUA requires that the wets lime residual be hauled away as soon as it is

removed from the storage areas.





13. Question:	Does FPUA anticipate more than 26 tons/6,000 gallons daily?
Answer:	Due to ongoing maintenance or water demands it is possible for three (3) to four (4) loads on some days.


