

RESOLUTION 23-R\_\_

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AND EXECUTE A SUPPLEMENTAL AGREEMENT TO THE LOCAL AGENCY PROGRAM AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION TO PROVIDE INCREASED FUNDING FOR THE CONSTRUCTION OF A SIDEWALK PROJECT ALONG NW SELVITZ ROAD FROM FLORESTA DRIVE TO NW BAYSHORE BOULEVARD; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City of Port St. Lucie (the “City”) received initial federal funding assistance in the amount of \$344,650.00 through a Local Agency Program Agreement (the “LAP Agreement”) with the Florida Department of Transportation (the “FDOT”) for the construction of a sidewalk on Selvitz Drive (the “Project”); and

**WHEREAS**, the City has now been issued a Supplemental Agreement to the LAP Agreement with the FDOT which proposes to increase the amount of federal funding assistance for the Project by an additional \$100,268.00, raising the total FDOT participation amount to \$444,918,00; and

**WHEREAS**, the total construction cost of the Project is estimated to be \$484,343.13, and the \$444,918.00 in total federal assistance funds will be applied towards that total cost once available to the City through the program’s cost reimbursement approach; and

**WHEREAS**, the FDOT has allocated funds represented in the LAP Agreement; and

**WHEREAS**, the FDOT has requested that the City adopt a resolution expressing support of the Project and authorizing the City Manager to enter into and execute the Supplemental Agreement; and

**WHEREAS**, as expressed in Resolution 22-R117, the City supports the Project and desires to continue to pursue the Project in partnership with the FDOT.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, THAT:**

RESOLUTION 23-R\_\_

1. The City Council adopts and ratifies those matters set forth in the foregoing recitals.

2. The City Manager, or his designee, is hereby authorized to enter into, execute and deliver to FDOT the Supplemental Agreement to the LAP Agreement, and such other documents as are necessary to implement the terms of the Supplemental Agreement and LAP Agreement.

3. The City Manager and City Engineer, and/or their designees, are hereby authorized to take all actions necessary to work with the FDOT to accomplish the purposes set forth therein.

4. If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

5. This Resolution shall become effective immediately upon its adoption.
