The City Clerk read Ordinance 22-40 aloud by title only. Mayor Martin opened the Public Hearing & asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed. There being no further discussion, Vice Mayor Caraballo moved to approve Ordinance 22-40. Councilwoman Morgan seconded the motion. The City Clerk restated the motion as follows: for approval of Ordinance 22-40. The motion passed unanimously by roll call vote.

- 8.b** Ordinance 22-42, Quasi-Judicial, Public Hearing, An [2022-380](#)
Ordinance Amending the Master Sign Program for the City
Center PUD (Planned Unit Development) (P20-246).

The City Attorney read the Quasi-Judicial Procedures into the record for item 8 b.) and 8 d.). The City Clerk administered the Oath of Testimony to staff and other interested parties & read Ordinance 22-42 aloud by title only. Mayor Martin inquired if there was any ex-parte communication, to which Vice Mayor Caraballo, Mayor Martin, Councilman Pickett, and Councilman Bonna replied that they spoke with staff on the item. Mayor Martin opened the Public Hearing. (Clerk's Note: A PowerPoint was shown at this time.) Daniel Robinson, Planner I, stated that he had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. He explained that the item

was the second amendment to the City Center Master Sign Program which would allow for additional City Center PUD signage & includes digital signage. He stated that the Planning & Zoning Board had recommended approval.

Mayor Martin asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed. There being no discussion, Councilman Bonna moved to approve Ordinance 22-42. Councilman Pickett seconded the motion. The City Clerk restated the motion as follows: for approval of Ordinance 22-42. The motion passed unanimously by roll call vote.

The City Clerk read Ordinance 22-43 aloud by title only. Mayor Martin opened the Public Hearing. The City Manager explained that the item was a utility bond with a maturity of 2029 and the City had the opportunity to call the bond early through the bank. Stephen Okiye, Finance Division Director, stated that the City would save around \$1.45 million.

Mayor Martin asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed. There being no further discussion, Councilwoman Morgan moved to approve Ordinance 22-43. Councilman Pickett seconded the motion. The City Clerk restated the motion as follows: for approval of Ordinance 22-43. The motion passed unanimously by roll call vote.

- 8.d** Ordinance 22-44, Quasi-Judicial, Public Hearing, An Ordinance Providing for the Fourth Amendment of the Planned Unit Development Document and Conceptual Development Plan for St. Lucie Lands Planned Unit Development, Located East of the Florida Turnpike and North of the Martin County Line (P21-281).

The City Clerk read Ordinance 22-44 aloud by title only. Mayor Martin inquired if there was any ex-parte communication, to which Vice Mayor Caraballo and Mayor Martin replied that they spoke with the applicant on the item. Mayor Martin opened the Public Hearing. (Clerk's Note: A PowerPoint was shown at this time.) Laura Dodd, Planner II, stated that

she had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. She stated that the request was for approval of the fourth amendment to the St Lucie Lands PUD. She showed the location with an aerial and explained the Zoning, the Future Land Use, and the Conceptual Plan. She said that the request was consistent with the City's Comprehensive Plan as was the traffic statement. She added that the Site Plan Review Committee and the Planning & Zoning Board had recommended approval.

Dennis Murphy, Culpepper & Terpening, stated that this item and item 13 a.) were related therefore his presentation would include both items. (Clerk's Note: A PowerPoint was shown at this time.) He stated that the area was called Veranda Falls which was located off of Becker Road and the Turnpike. He then gave the history of the property along with the next project of the area, the Community of Caring Hospital with over 700 parking spaces. He stated that they were hoping to start construction in the fourth quarter with a completion date in Fall of 2024. He explained to the City Council that they were still creating a Master Sign Program for the area to relieve any traffic concerns. He said that the administrative office building will be built along with the hospital. He stated that the original PUD did include a helipad, which will be constructed, but no helicopter would be based there it would be used to fly patients in/out of the area. He explained that after the hospital and office building were constructed, they would have 80,000 sq ft office space with some retail components available. Vice Mayor Caraballo inquired about the conceptual landscaping plan, to which Mr. Murphy stated that under the PUD they had to meet enhanced landscaping.

Mayor Martin opened the Public Hearing & asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed. There being no further discussion, Vice Mayor Caraballo moved to approve Ordinance 22-44. Councilwoman Morgan seconded the motion. Ms. Dodd explained that the item was requesting approval of a 181,925 square foot, 54 bed hospital and a 60,000 square foot medical office building. She showed the location with an aerial and explained the Zoning, the Future Land Use, and the Conceptual Plan. She said that the request was consistent with the City's Comprehensive Plan as was the traffic statement. She added that the Site Plan Review Committee had recommended approval.

There being no discussion, Vice Mayor Caraballo moved to approve Item 13 a). Councilman Pickett seconded the motion, which passed unanimously by voice vote. Vice Mayor Caraballo requested that the applicant work with the Communications Department on a Public Service Announcement to get the residents excited about the project.

The City Manager informed the City Council that there was a Covid surge, but staff was conducting business safely. Mayor Martin asked for clarification regarding the recycling issues, to which Carmen Capezzuto, Neighborhood Services Director, explained that they were working to get schedules back on track (1-2 weeks) and WastePro was picking up recycling along with the garbage; he stated that it could be in the bin or in a bag. Mayor Martin requested that the information be passed onto the residents.
