WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1A. The following Contract language is modified to reflect the correct CPI Index to use for determining the possible increase/decrease for all renewals.

This contract allows for a price redetermination based on the U.S. Department of Labor, Bureau of Labor Statistics, and Consumer Price Index – All Urban Consumers - U.S. City Average—Transportation—Gaseline (All Types) Motor Vehicle Maintenance and Repair in U.S. City Average Not Seasonally Adjusted at time of renewal only.

The Contractor must request such an adjustment in writing no later than ninety (90) days prior to the renewal date and must include in the written request documentation that the Contractor has incurred bona fide cost increases in providing services under this Contract during the period in which the request is made. The City will not allow Consumers Price Index contract adjustments, up or down, to exceed five (5%) percent combined total in any one period. Any increase will be effective on the contract renewal date.

Price Adjustment will be based on the annual index (Un-Adjusted) using the published figures from each December for a period of one year (example: December 2019 – December 2020) ene month prior to the renewal date. The price adjustment will be calculated on the simple percentage method.
