

**ORDINANCE 23-**

**AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, REZONING APPROXIMATELY 5.8 ACRES OF LAND, LOCATED ON THE SOUTH SIDE OF BECKER RD., BETWEEN SW LASSITER TER. & SW JUNIETTA TER., FROM PLANNED UNIT DEVELOPMENT (PUD) ZONING DISTRICT TO PROFESSIONAL (P) FOR PROPERTY LEGALLY DESCRIBED AS BECKER COMMONS, (PB 62-1), LOTS 1, 2 AND 3 (P23-115); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, A M Developments LLC., seeks to rezone approximately 5.8 acres of land located on the South side of Becker Rd., between SW Lassiter Ter. & SW Junietta Ter., and within the City of Port St. Lucie, from Planned Unit Development (PUD) Zoning District to Professional (P) Zoning District; and

**WHEREAS**, the proposed zoning is consistent with all applicable elements of the City’s adopted Comprehensive Plan and complies with the City’s Code of Ordinances; and

**WHEREAS**, the City of Port St. Lucie Planning and Zoning Board held a public hearing on September 5, 2023, to consider the rezoning application (P23-115), notice of said hearing to adjoining property owners for a radius of seven hundred and fifty (750) feet having been given and advertising of public hearing having been made; and

**WHEREAS**, the City Council held a public hearing on October \_\_, 2023, to consider the rezoning application (P23-115), advertising of the public hearing having been made; and

**WHEREAS**, the City Council has considered the rezoning application (P23-115) based on substantial and competent evidence and the City Council has determined to rezone the property legally described as Becker Commons Lots 1, 2, and 3 as recorded in Plat Book 62, Page 1 of the Public Records of St. Lucie County.

**NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:**

## **ORDINANCE 23-**

**Section 1. Ratification of Recitals.** The City Council of the City of Port St. Lucie, Florida, hereby adopts and ratifies those matters as set forth in the foregoing recitals.

**Section 2.** That the property located on the South side of Becker Rd., between SW Lassiter Ter. & SW Junietta Ter., and legally described as Becker Commons Lots 1, 2, and 3 as recorded in Plat Book 62, Page 1, of the Public Records of St. Lucie County, be rezoned from Planned Unit Development (PUD) Zoning District to Professional (P) Zoning District.

**Section 3. Conflict.** If any ordinance, or parts of ordinances, or if any sections, or parts of sections, of the ordinances of the City of Port St. Lucie, Florida, are in conflict herewith, this Ordinance shall control to the extent of the conflicting provisions.

**Section 4. Severability.** The provisions of this Ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

**Section 5. Effective Date.** That this Ordinance shall become effective ten (10) days after its final adoption.
