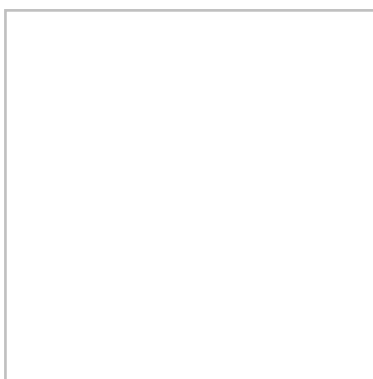

Good afternoon Neo,  
Does this price include all the paint, and the special primer, painting the soffits, the porch ceiling, all the doors, the fascia and garage door. These are things I need to know in advance before I'm able to move forward.  
My finances are running quite thin.

Hi Mrs Carol, yes everything including Labor and Materials in all does areas. No extras

Hi, Mrs. Carol, I'm glad you are back. For the labor and materials, we had a little over \$1,200.00 to \$1,300.00. Labor was a little over 3K, and the rest was labor involved in fixing all the rotten areas, scissoring all the 2 x 4 that was damaged, and installing a paper moisture barrier to protect against humidity. So here's the breakdown. The fascia board is not included on the list because we only did the soffit and walls. And the areas of the bare plywood on the overhang, we need to prime that when you are ready to do the exterior repaint. Remember that your stucco job was done more than three weeks ago and cannot be exposed like that for a long time; you might have problems with cracking if we do not start painting. Let me know when you get this.

The fascia should be an easy fix. I will call my roof repair guy; he is very reasonable, and he can fix all of those areas for you for cheap. I'm going to ask him to stop by to check the areas; let me know if it's okay with you.

Thanks Neander Oliveira

Any further repairs on this house are going to have to wait. I am broke after paying out \$40,000 in repairs for the interior and exterior of the house. I'm still waiting on retirement funds. I live on \$1,900 monthly and do not have any funds to cover any further expenses. Okay, I understand. I'm just looking out for you, especially regarding having bare concrete exposed on your exterior, as that can create more problems eventually. But let me know when you're ready. I'll try to work it out with you.

Thanks Neo, I'll be in touch as soon as I have an answer for you. I've been in touch with the necessary person regarding my husband's 401k plan and have completed my part of the beneficiary transfer. I was assured by the person handling it that she would expedite the process as quickly as she can. I do have several questions though ?

Shouldn't the moisture barrier having to be placed on top of my wood frame home been included in the original quote since it was known at the time that it was needed for a wood frame built house.

I'm very confused by your pricing.

I was given a quote of \$17,500 when you, myself and Damon walked the entire perimeter and saw the damage that needed to be replaced and or repaired. You came back to me and said that we weren't able to go with "the white guy" (whom I'm guessing was Damon) because he was going to be too expensive wasn't that who you received the \$17,500 quote from?

You then hired Manuel, whom I'm guessing was less expensive. What was his quote compared to the quote that Damon had given of \$17,500.

I've been asked these questions by several people, including family members. I'd like to provide them with the correct information. These are questions that I should've brought up prior to the job being started.

You had also stated at the time that the painting and priming were going to be included and that's not the way it played out. The exception to the quote was the window frames and the hurricane posts, which I was told was going to be an extra fee and could not be done until the house was sealed and painted. I'm just looking for clarification on these things. Like I said, several people have asked me about these things and I don't have answers for them.

One of them is interested in having either stucco or hardy boards placed on their homes and are trying to weigh out the differences between the two exterior options.

I'd like to be able to provide them some insight and information

I hope you get your husband's pension straightened out. Good luck with that, for sure. I know from the initial quote, but we had some surprises, so imagine with my other crew it will cost at least 6 to 7K more, and I am trying to do the most costly effect for you, and I know Manuel.



He is more reliable than anybody and a man of his word, just for you to know. I do trust his work; the stucco looks great. But the paint is definitely separate from the stucco job, two different things. Hardboard will definitely be way more expensive than stucco. I will try to find you a quote, just for you to have an idea. I will call you tomorrow for us to talk about a little bit more, have a great afternoon.

I have an appointment this week in order to have my late husband's retirement switched over into my name so I'm able to access funds. I'm unable to move forward with anything regarding my house until I have the ability to move funds from the retirement account into my bank account. Hopefully this will not be a time consuming process.

I'll be leaving town this upcoming weekend to attend my grandson's 10th birthday celebration on the West Coast of Florida and will be back sometime next week.

Hi Mrs. Carol, I understand, I hope you feel better. No problem, let me know when you're back. Be careful, don't let the stucco sit for too long without painting. Keep me posted, enjoy the birthday weekend.

As far as the stucco goes with sealing and painting, I've been told it needs to cure for 30-90 days, no??

Good morning Neo, I have arrived back in town as of this past weekend.

I'm still awaiting a breakdown of the material and labor costs put into the work done on my home.

You had previously stated that extra materials were needed to replace fascia and soffit in several different places. My brother came down for a visit over the weekend, wanting to see the completed work.

Mr. Peter let me introduce myself. I am Mark Davis a proud multiple holder licenses holder in the State of Florida as yourself, CGCO44476, CCC057473, CCC1332979, MRSR5139, MRSA5060. All active and in good standings.



I lived in PSL from 1983-2001 and built my own home on Doat Street in 1986. I worked on my own projects during that time that I did with my GC license outside of my full time job and worked for DiVosta homes full time construction as many as 10,000 homes in my tenure there.

That being said, I am extremely upset that this has happened to a resident of the City I used to call home! I have a friend of a DiVosta workmate that his widow, Carole Burtis at 1602 Apricot Street PSL, FL 34953, her local number is (772) 834-2834, has been taken advantage of and is experiencing such financial stress from a series of events that has driven her to her brink of desperation. She has had to take on repairs to her home over the last 5 years, roof replacement, HVAC, and now siding, and unfortunately several times now she has been taken advantage of.

A company solicited Mrs Burtis, Direct Energy of Florida with malice and intentional deceptive business practices, hired a out of town vendor to slap in a system and couldn't even speak english to explain how to set up her thermostat, as she was lured in by energy savings of a new HVAC unit to lower her monthly costs, finances through (Hotel Services Inc that no one would address multiple calls from Mrs. Burtis, their call center is in the Philippines, another scammer offering be able to have them finance such a loan offering. Direct Energy of Florida I do not believe has any contractors licensing.. They then sent Olivero Air Conditioning Inc from 1309 trails End Court, St Cloud, FL 34771 - CAC-183438 to do equipment changing, their permit #2440757 was denied 10/16/2024 from the PSL Building Department, by the way the equipment change out was done without a permit last year!! . A second permit #2537388 was submitted 09/25/2025 and just approved 09/30/2025 so now they are trying to cover their tracks?? When does the city allow work to be done without a permit??

Ms Burtis doesn't even know if the equipment was installed correctly as she had to find a local Trane certified contractor to make warranty repairs as calls to this original out of town licensed contractor didn't return to make necessary adjustments so the system would stay within factory warranty and function correctly!! The repair technician said it was the lowest SEER rating that they installed, I do not know what the efficiency rating should have been last year or this year as the permit was submitted for actually last week?

I do apologize for the length of this communication...

Now, to the next matter a unlicensed person, Mrs Burtis, informed me that she was persuaded to submit her own permits directed by non licensed persons, Neander Quality Services Inc, Remodeling and Painting, as I have searched for them, are not licensed to to structural repairs and now has stopped work to come back to her for additional payments to finish the verbally agreed scope of work. Neander was actually taken to small claims court in St Lucie County in the past.

I realize, I am only a personal family friend, but I hold my integrity line when it comes to companies and so called contractors cross the line of our profession and that is so upsetting that this kind of thing happened to someone I personally know and think why so many people don't trust contractors in general when many of us are honest and have moral values. That these kind of crooks prey on the innocent consumers, MUST BE HELD RESPOSIBLE.

I with filing a formal complaint in this matter with the DBPR today.
