On September 3rd, 2025, at approximately 9:00pm, I responded to a call for service regarding a reported fraud incident at 436 SE Skipper Lane. Upon arrival, I made contact with the complainant, Vicki Lombardi, who provided details about a contractor, Adam Gibbs, of Adam Gibbs Construction, LLC, allegedly committing financial fraud.

The complainant stated that she had hired Adam Gibbs to perform kitchen renovations and had paid him a total of \$32,000 through a combination of electronic transfers and checks. She explained that the payments were made in accordance with a contract Gibbs had provided, which outlined specific amounts and timelines for the work. However, she later discovered that Gibbs was not a licensed contractor and had failed to complete the agreed-upon work.

Lombardi provided documentation, including copies of checks and a letter from her bank, PNC, detailing the fraudulent activity. She explained that on March 5th, 2025, she issued a valid check (#1003) for \$3,634 to Gibbs, which he electronically deposited. On August 26th, 2025, the same check was fraudulently resubmitted with alterations to the back of the check and was processed by a bank in Minnesota. Lombardi stated that this resulted in an additional \$3,634 being withdrawn from her account.

The complainant further stated that she had fired Gibbs in May 2025 due to his failure to complete the work and his misrepresentation as a licensed contractor. She had also filed a complaint with the relevant licensing board, which was under investigation. Lombardi expressed suspicion that Gibbs had intentionally duplicated the check, citing his history of unprofessional behavior and financial misconduct.

Lombardi provided additional details about the payments made to Gibbs, which included an initial electronic transfer of \$20,000 on December 24th, 2024, followed by checks #1001 (\$8,356 on February 4th, 2025), #1002 (\$8,000 on February 26th, 2025), #1003 (\$3,634 on March 6th, 2025), and #1004 (\$2,104 on April 2nd, 2025). She confirmed that the fraudulent activity was limited to check #1003.

Lombardi also mentioned that the fraudulent check bore a thumbprint, which she believed could be used as evidence to identify the individual responsible. She expressed frustration with the bank for processing the duplicate check and stated that she had reported the incident to PNC, which was conducting its own investigation.

During the interaction, Lombardi also described the incomplete work left by Gibbs, which included a partially installed kitchen and a ceramic tile floor. She stated that the situation began after a waterline broke in her home in November 2024, causing significant damage. She hired Gibbs based on a recommendation from another contractor but later discovered his lack of licensing and failure to pull necessary permits.

Lombardi provided additional documentation, including a complaint filed with the city and licensing board regarding Gibbs' misrepresentation as a contractor. She stated that she had been in contact with a detective investigating the licensing issue but had not received updates on the fraud case.

All evidence was submitted to records and scanned for submission to a detective at a later time.

BWC was utilized. No further information at this time.






