The following modifications to the Terms and Conditions contained in Contract # 20040116 between Aquatic Vegetation Control, Inc., and the City of Port St. Lucie are hereby incorporated and made a part of that Contract.

- 1. Scope of work is to provide aquatic weed control services for:
 - 1.1. Two and one-half (2 ½) acre lake located in the southwest corner of SE Village Green drive and SE Walton Road, behind the Civic Center.

1.2. Five (5) acre lake on the south end of same property as listed above.

Services include providing herbicide aquatic weed control services, treating Southern water grass, Torpedo grass, Barnyard grass, Southern Naiad, Hydrilla, Alligator weed, Limnophila and any other aquatic weeds.
The Two and one-half (2 ¹/₂) acre lake, requires an initial treatment and clean up during the first two (2)

months with twelve (12) monthly maintenance treatments to follow.

2.2. The five (5) acre lake requires fourteen (14) maintenance treatments only.

3. First fourteen (14) month pricing, for the two (2) lakes is as follows:

- a. Month #1 \$636.75
- b. Month #2 \$636.75
- c. Month 3-14 \$301.75 per month
- d. Future years at an amount agreed upon by both parties.
- 4. This contract allows for annual price determinations, not to exceed 5%, based on the U.S. Dept of Labor, Bureau of Labor Statistics, Consumer Price Index All Urban Consumers (CPI-U), all items, as found on this site: <u>http://www.bls.gov/data/#prices</u>. The City will base the annual determination starting with comparison of the September 2008 -All Items, results. The City will base following years on the CPI-U comparison of September of that year.
- 5. Original Contract Amendment #5 period is for fourteen (14) months. Either party may renew this amendment an additional year or years unless cancelled by either party in writing, with thirty (30) days notice. Future renewals will be concurrent with the main contract #20040116.
- 6. All other terms and conditions of the original contract and/or Addenda apply.
