SUBJECT TO conditions, easements, limitations and restrictions of
record; particularly those imposed upon the Grantor hereof by that
certain Warranty Deed of record in Official Records Book 362, at
Page 256, of the Public Records of St. Lucie County, Florida.

This is a Corrective Warranty Deed given to correct an earlier Deed
recorded May 21, 1982, in Official Records Book 376, Page 2577, of
the Public Records of St. Lucie County, Florida.

Together with all the tenements, hereditaments and appurtenances thereto belonging or in any-
wise appertaining.

To Have and to Hold, the same in fee simple forever.

And the grantor hereby covenants with said grantees that it is lawfully seized of said land in fee
simple; that it has good right and lawful authority to sell and convey said land; that it hereby fully war-

BEGINNING AT THE SOUTHWEST CORNER OF TRACT "E"; THENCE N 27°53'44" W ALONG THE NORTHERLY RIGHT-OF-WAY LINE OF HILLMOOR DRIVE A DISTANCE OF 212.22 FEET TO A POINT OF CURVATURE; THENCE NORTHWESTERLY ALONG THE ARC OF A CURVE CONCAVE TO THE SOUTHWEST HAVING A RADIUS OF 550 FEET THROUGH A CENTRAL ANGLE OF 4°44'32" A DISTANCE OF 45.52 FEET; THENCE N 54°35'01" E A DISTANCE OF 88.01 FEET TO A POINT OF CURVATURE; THENCE NORTHEASTERLY ALONG THE ARC OF A CURVE CONCAVE TO THE SOUTH HAVING A RADIUS OF 147.50 FEET THROUGH A CENTRAL ANGLE OF 12°00'00" A DISTANCE OF 30.89 FEET TO THE POINT OF TANGENCY; THENCE N 66°35'01" E A DISTANCE OF 215.00 FEET TO A POINT OF CURVATURE; THENCE NORTHEASTERLY ALONG THE ARC OF A CURVE CONCAVE TO THE NORTH HAVING A RADIUS OF 282.50 FEET THROUGH A CENTRAL ANGLE OF 28°49'58" A DISTANCE OF 142.16 FEET TO A POINT OF REVERSE CURVE; THENCE SOUTHEASTERLY ALONG THE ARC OF A CURVE CONCAVE TO THE SOUTH HAVING A RADIUS OF 20.0 FEET THROUGH A CENTRAL ANGLE OF 83°49'57" A DISTANCE OF 29.26 FEET TO THE POINT OF TANGENCY; THENCE S 58°25'00" E A DISTANCE OF 208.82 FEET TO A POINT IN THE EAST LINE OF SAID TRACT "E"; THENCE S 04°03'30" E ALONG SAID EAST LINE A DISTANCE OF 97.90 FEET TO THE SOUTHEAST CORNER OF SAID TRACT "E"; THENCE S62°06'16" W ALONG THE SOUTH LINE OF SAID TRACT "E" A DISTANCE OF 561.05 FEET TO THE POINT OF BEGINNING.
