Could you please provide the link to connect to the Virtual Meeting on Wednesday?

My nephew, a City Manager in Indiana, would like to observe the proceedings. We also have several members of the community that would like to be heard. They will be respectful.

We have significant concerns regarding the rezoning of this parcel and its alignment with the City's Comprehensive Plan, Policies, and Objectives. We also want to ensure that the initial zoning complies with the required State Chapter 429 for Group Homes and Assisted Living, as specified in our Building Codes.

Moreover, we request a thorough screening of the buyers, if it is possible, Ms. Buckley from Prospera Realty and Mr. Chris Desl from Baywood Hotels, before any major changes are approved by the city, again If allowable.

We are concerned, as we know neither of the buyers have any experience building, or operating a medical facility. If the zoning change is allowed and the buyers cannot obtain approval from AHCA, the land use will be changed forever.

We will respectfully send you and Bridget a list of further concerns that the residents have regarding this Agenda item since we currently do not see a location to upload items for public comment. You should have another correspondence on Monday from us

While the residents are open to an ALF being built, they strongly resist increasing the footprint to 11 DU per acre and rezoning to allow a 75-unit "apartment building" with parking variances, setbacks, and other requests as well as outbuilding

Our group is striving to keep the 1,000-plus residents, that have petitioned against this zoning change, organized to prevent overwhelming the city with individual comments.

We hope that you will add our past and future correspondences to the comments for both Agenda Items for this project, I know we have sent the City Council, and the planning and Zoning Board quite a few emails

We recognize your responsibility to represent the owner's interests, but please do not overlook the voices of the neighborhood residents. Many feel as if they are unrepresented and have no voice within our city.

Requesting assistance from our City Council and Administration

Concurrency Determination - Transportation "Traffic Study"

We would like to respectfully ask if the Planning and Zoning Board would consider these options in relation to the proposed Traffic Study for Westmoreland Blvd and Morningside Blvd (Policy 2.1.2.2). We note that the residents respect the developers' Property Rights under Ordinance 21-76 but maintain that this Ordinance is also relevant to the residents of the area and its community.

We are providing some documentation from the City's Comprehensive Plan to assist with any

time involved in research.

Respectfully, we are requesting: The City utilize the developer's Traffic Study to also complete a CMS - 2 Tier Congestion Management Plan for the area prior to any approval of the development. We ask that this CMS be inclusive of the possibility that the Golf Course - formerly known as "The Sinners" may in the future be developed as a Multi-Level Residential site. This is unknown at this time.

We request that the City consider the effects on traffic during the buildout of the property and how to mitigate any travel restrictions during this time (Policy 2.1.2.9).

We also request (Policy 2.1.1.5) - That a new Review of Accident Data be initiated due to the 2 recent fatal accidents on Westmoreland Blvd in the past month.

We are requesting the location of ingress and egress for the proposed development to determine relevant traffic on the collector roadways (Policy 2.1.2.3)(Policy 2.2.1.2).

Vicinity map showing transportation routes to be impacted by the development; inclusive of the need for U-Turns or one-way ingress or egress.

Traffic from the development expressed in terms of current average daily traffic along with directional distribution (D factor), peak hour demand (K ratio) and percentage of trucks to include projected School Buses and estimated Emergency Medical vehicles (T factor), in the traffic stream.

Inclusion of the roundabout located at Westmoreland and Morningside with regard to its functional capacity and safety and operation relative to the sum of the traffic study results.

Effects upon Sidewalks and Bike Pathways along both collector Roadways - and any proposed developer plans to add or make modifications to these items (Policy 2.1.2.13)(Objective 2.1.4) (Objective 2.2.1)(Policy 2.2.1.1)(Objective 2.3.1)(Policy 2.3.1.4)(Objective 2.3.2)(Policy 2.3.2.1 -To protect our School Children that do not ride a bus or walk home).

Any Growth Projections expected if the project development will not be completed within 2 years.

Projected 10-year Average Daily Traffic Pattern/s after completion of the project.

Inclusion of the existing failure of the roadways along Westmoreland Blvd as well as Morningside due to current traffic volume (Objective 2.1.2)(Policy 2.1.2.11) - with potential impact on the collector roads related to the projected Average Daily Traffic Sum and its impact on the Ten-Year Repaying Master Plan.

Potential Impact on future City-Owned Transportation Services - once an Increased City-Wide Shuttle / Bus system is established to routinely service this area - Currently most Routes are along US1 but due to population expansion this may be subject to change (Policy 2.1.4.3) (Objective 2.2.2)(Policy 2.2.2.2)(Policy 2.3.3.2). This may be more relevant due to the type of Buildout that is anticipated

This will also assist in evaluation of the traffic increase due to the increase in Student attendance at the schools along Morningside Blvd.

Although not officially part of the Transportation Review - We request the Setback distance and proposed height of the structure to be located along Westmoreland Blvd - We ask this for review to determine any field of vision obstruction which may lead to an unintended traffic hazard (Policy 2.1.2.4)(Policy 2.3.3.7).

Although not part of this Traffic Study, we respectfully ask the City consider the effects upon Port St Lucie Blvd - Especially from the intersection of Westmoreland/Veterans Pkwy to East and West of the intersection - Adaptive Signalization is in place yet the roadway remains very congested during Peak Hours.

Dear Director of Emergency Services - Mr. Guerrero,

I'm writing to urgently bring to your attention the proposed Assisted Living Complex in Port St. Lucie, referenced as Agenda Item P24-070 and P24-033 for the Planning and Zoning Board, as well as the City Council's future Agenda

The site is located around and behind the Max Gas station at 2780 SE Morningside Blvd, Port St. Lucie, FL 34952.

Residents are gravely concerned, as the facility will obstruct the only evacuation route available to approximately 3,000 residents, 375 employees of the Sandpiper Bay Resort (formerly Club Med), potential hotel guests, and potentially another 5,000 residents who may need to use Morningside Blvd if flooding blocks access to areas east of the development.

The neighborhood narrowly avoided disaster during the recent Hurricane Milton Tornado, with one tornado hitting less than half a mile from the proposed site, further continuing on to cause significant damage and deaths to elderly residents of the nearby Spanish Lakes Complex.

Residents are urgently requesting your review of the evacuation plans for this area. Over 900 to 1000 residents have already Voiced their concerns to the Port St. Lucie Planning and Zoning Board and City County Council but have yet to receive a response.

This site plan is up for review on Wednesday, October 23rd. Making this an urgent matter for review.

The evacuation of a 375-patient/resident facility is a major undertaking, and we urgently need your help.

§ 158.110. Institutional Zoning District (I)

I am writing to express my deep concern about the proposed zoning change for the development on Westmoreland and Morningside. While I recognize the potential benefits of development, this project raises multiple, substantial issues impacting our community's health, safety, and quality of life.

Firstly, the urgency with which this zoning change is being pushed through is troubling. Expediting this process without addressing the substantial concerns raised by the community suggests a disregard for necessary due diligence. Moving this issue swiftly from the Site Review Committee to the Planning and Zoning Board—and soon after to the City Council—raises questions about whether community voices are being considered.

The development's location has several critical challenges that remain unresolved:

- 2. **Evacuation and Safety**: Westmoreland and Morningside are not equipped to handle the increased evacuation needs a large-scale development would demand in case of emergencies. Has an evacuation and safety study been conducted, and if so, what were the findings?
- 3. **Infrastructure Strain**: The current infrastructure is already strained. Adding further development will exacerbate road wear and tear, increase traffic congestion, and further degrade public utilities. What concrete plans exist to support this infrastructure if the zoning change is approved?
- 4. **Community Transparency**: Many residents were unaware of the proposed changes, and this lack of transparency is unacceptable. Meaningful community engagement must be prioritized, and all concerns must be carefully considered before any final decisions are made.

Please delay any final decision until these issues are fully addressed, with all reports and findings transparently shared with the public. This

development's long-term impact on our community must not be underestimated, and I urge the Board to prioritize our community's welfare and safety.
