WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1. Additional scope of work for the adjustment to the existing lighting pull boxes that are currently too low with respect to the new site conditions. Total amount for the additional work is \$13,457.45.
- 2. Additional scope of work for the removal of the unforeseen 24" exfiltration system. Total amount for the removal of unforeseen work is \$5,587.15.
- 3. Hurricane lan decimated the Fort Myers area and carved a swath if destruction through the center of the state. These impacts have crippled our resources and is hindering our production. Trucking companies that were established for this project have all went to the west coast to assist with the cleanup. We are in the process of scheduling additional resources from New Jersey to assist with this work. As a result, we are asking for and additional 90 calendar days.
- 4. Additional calendar days are needed for recent weather events:
 - 9/27 Secure jobsite
 - 9/28 & 9/29 Hurricane lan
 - 9/30 Repair damaged silt fence, temp fence, gawk screen & turbidity curtain
 - 10/1 Adverse soil conditional render site unworkable
 - 11/8 Secure jobsite
 - 11/9 & 11/10 Hurricane Nicole
 - 11/11 Repair damaged silt fence, temp fence, gawk screen & turbidity curtain
 - 11/12 Adverse soil conditional render site unworkable
 - Total additional calendar days 100 days
- 5. **SUCCESSORS AND ASSIGNS.** This Amendment shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
- 6. **ENTIRE AGREEMENT.** Except as expressly modified by this Amendment, the contract shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Amendment and the contract (including any written amendments thereto), collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
