NOTICE OF CITATION ORDER HEARING

On 04/01/2025 Akpo Olokor filed a police report with Ofc. Goldstein with the Port St. Lucie Police Department.

Olokor reported the following to Ofc. Goldstein: On 02/12/2025 he entered into a contract with Justin Fulwood to install a new AC at his residence located at 2218 SW Newport Isle, Port St. Lucie, Florida 34953. Fulwood quoted \$3,276 to complete the job and obtained a deposit of \$2,276 via Zelle utilizing Fulwood's phone number 772-267-7233. As of 04/01/2025 Fulwood failed to start the job.

It should be noted that phone number 772-267-7233 is linked to Fulwood in past criminal investigations where Fulwood was arrested for violation of F.S.S. 489.127 Contracting without a License in case number 2023-19835 where Fulwood was ultimately adjudicated guilty for a felony due to having a prior conviction for the same charge.

Olokor had previously done business with Fulwood and positively identified him via a Facebook picture which matched his photo on DAVID.

I spoke to Olokor and confirmed the details in the initial report and requested text messages between him and Fulwood, along with a copy of the invoice and payment details. It should be noted that Fulwood was not going to obtain permits because there would be an additional cost if he obtained permits.

Olokor provided an Invoice from Justin's Air Service dated 02/12/2025 addressed to Olokor for an AC unit for \$3,276.00 with a payment of \$1,000.00 and remaining balance of \$2,276.00. Olokor also provided Zelle transaction receipts totaling \$2,276.00. No license number was listed on the invoice; however, the invoice listed under the description it was for a 2 ton Carrier 15 seer split system, 5kw electric heat, Hurricane straps, Float switch, Metal stand, Drain pan, with a 10 year parts warranty and 1 year labor warranty and based on the text message conversation between Fulwood and Olokor Fulwood would be installing the AC unit.

Olokor provided the following text messages between himself and Fulwood:

-On 02/10/2025 Olokor sent a text message to Fulwood advising he was ready to replace his AC.

-Olokor and Fulwood communicated about price and brand.

-On 02/12/2025 Fulwood sent Olokor a text message with a link for an estimate to review and approve and identified the company as Justin's Air Service.

-On 02/13/2025 Olokor sent a text message stating "Hi Justin. Sent \$2276. 1276 already today n 1k last night."

-Olokor continued to discuss the details of the AC unit and on 02/24/2025 Fulwood told Olokor he had him on the schedule for tomorrow. The following day, 02/25/2025 Fulwood failed to show up and claimed it was due to rain on 02/24/2025 and said he would be there on 02/26/2025. Fulwood failed to show up on 02/26/2025 and claimed it was due to a family emergency. Fulwood continued to set dates; however, failed to show up and start the work. On 03/14/2025 Fulwood sent a picture of a swollen foot and claimed he broke his foot but said his guys would do the job. Again, nobody showed up to do the job.

-On 03/17/2025 Olokor requested a refund and Fulwood agreed to refund his payments in full; however, Olokor was never refunded.

Olokor paid Fulwood via Zelle; therefore, I obtained Fulwood's Zelle records via a subpoena. The following information was obtained:

-On 02/12/2025 Fulwood received \$1,000.00 from Olokor.

-On 02/13/2025 Fulwood received \$1,000.00 from Olokor.

-On 02/13/2025 Fulwood received \$276.00 from Olokor.

-Fulwood received the above Zelle payments into a Bank of America Bank Account

I obtained the following from Bank of America via a subpoena:

-The above Zelle payments from Olokor were deposited into Bank of America account number [REDACTED] belonging to Justin Fulwood as the sole owner/signor on the account.

-02/06/2025 the account had a balance of -\$2.63.

-Between 02/07/2025 and 03/10/2025 \$23,047.10 was deposited into the account and 23,193.87 was debited from the account.

-No AC related purchases were made before or after Fulwood obtained the payments from Olokor.

-The subsequent debits were cash withdrawals and personal transactions including but not limited to gas station transactions, food and numerous gambling transactions.

A search to verify if Fulwood obtained a permit to install the AC unit was conducted; however, no permits were found.

A search via the City of PSL Contractor Database and DBPR was conducted to verify if Fulwood was a licensed contractor; however, no license was found.

On 04/09/2025 Olokor sent Fulwood a Demand Letter requesting a refund of the \$2,276.00 he had paid him for the AC unit; however, Fulwood failed to obtain a permit, start or complete the job. There was no address listed for Fulwood on the invoice, nor was there an address available through the City of Port St. Lucie Contractor Search Website or DBPR. Olokor sent the Demand Letter to Fulwood at 1055 17th Lane SW, Vero Beach, FL 32962 (Delivered on 04/12/2025) and 212 N 41st St, Fort Pierce, Florida 34987 (Returned to Sender).

Justin Fulwood violated F.S.S. 489.127 Contracting without a License subsequent to prior conviction, due to him engage in the business or act in the capacity of a contractor or advertise himself or herself or a business organization as available to engage in the business or act in the capacity of a contractor without being duly registered or certified when he entered into a contract to install an AC unit for the victim, Akpo Olokor.

Justin Fulwood also violated F.S.S. 812.014 Grand Theft due to him knowingly obtaining \$2,276.00 for the purchase and installation of a new AC unit; however, Fulwood utilized all of the money for personal use with a significant portion being utilized for gambling and permanently depriving the victim, Akpo Olokor, of his funds.
