(Clerk's Note: A PowerPoint was shown at this time.) Francis Forman, Planner II, stated that he had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. He explained that the applicant was requesting to rezone a .23 acres of property from Single-Family Residential to Service Commercial. He explained the surrounding Future Land Uses & Zoning areas and added that the Planning & Zoning Board had recommended approval.

Mayor Martin asked if there was anyone who wished to speak on the item. There being no one else to speak the Public Hearing closed.

Councilwoman Morgan moved to approve Ordinance 23-62. Councilman Pickett seconded the motion, which passed unanimously by voice vote.

(Clerk's Note: A PowerPoint was shown at this time.) Francis Forman, Planner II, stated that he had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. He explained that the applicant was requesting to rezone a property just over an acre from single-family to general commercial. He showed an aerial & explained the surrounding future land uses and zoning. He added that the Planning & Zoning Board had recommended approval.

Alejandro Torro, Engineering, Design & Construction, stated that the property would be used for offices and restaurants but they were still working on the Site Plan.

Mayor Martin asked if there was anyone who wished to speak on the item. There being no one else to speak the Public Hearing closed.

Councilman Pickett moved to approve Ordinance 23-63. Councilwoman Morgan seconded the motion, which passed unanimously by voice vote.

Bethany Grubbs, Planner II, stated that she had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. She stated that the item was amendment #5 for the St. Lucie Lands Planned Unit Development and explained the six changes. She showed an aerial & Conceptual Plan and explained the Future Land Use & Zoning. She added that it was consistent with the City's Comprehensive Plan and the Site Plan Review Committee had recommended approval.

Dennis Murphy, Culpepper & Terpening stated that he was available for questions/concerns.

Mayor Martin asked if there was anyone who wished to speak on the item. There being no one else to speak the Public Hearing closed.

Bethany Grubbs, Planner II, stated that she had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. She explained that the applicant (the City) was requesting to rezone .96 acres from Institutional to

Neighborhood Commercial to be consistent with the City's Comprehensive Plan. She explained the surrounding uses and the Future Land Use & added that the Planning & Zoning Board had recommended approval.

Mayor Martin asked if there was anyone who wished to speak on the item. There being no one to speak the Public Hearing closed.

(Clerk's Note: A PowerPoint was shown at this time.) Bethany Grubbs, Planner II, stated that she had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. She explained that the applicant was requesting approval of the rezoning of approximately 5.8 acres from Planned Unit Development to Professional for a project that is consistent with the Professional Zoning District. She stated that the property was vacant, gave a brief background on the property and explained the Becker Overlay District.

(Clerk's Note: A PowerPoint was shown at this time.) Dan Siemsen, 2GHO, stated that he was the agent for the applicant and that a Major Site Plan application would be submitted after rezoning approval for a 67,200 sq. ft. 2-story medical office building. He provided information on the history and the Becker Road Design Standards. He informed the City Council that they held neighborhood meetings which were attended by two residents. Mayor Martin and Vice Mayor Caraballo voiced that they wanted buffering between the neighborhoods and beautiful landscaping.

Mayor Martin asked if there was anyone who wished to speak on the item. There being no one the Public Hearing closed.

Teresea Lamar-Sarno, Deputy City Manager, informed the City Council that staff had been working with St. Lucie County and Kolter regarding the Oak Ridge development. Mayor Martin stated that it wasn't a Resolution, it was more of an update since the agreement was not completed. Rich Berrios, Deputy City Attorney, informed the City Council that if the agreement was not accepted by October 12th, the Resolution would allow the City to preserve its rights and pursue an alternative method.

Colt Schwerdt, Interim Public Works Director, explained the roadway conditions that would be included into the mitigation agreement and the fair share agreement. Councilman Pickett requested live/daily updates. Mr. Schwerdt explained that there was a dispute over trip distribution which would be discussed at the next meeting. Vice Mayor Caraballo voiced that commercial properties could cause a disruption to trip distributions within the City. The Deputy City Attorney stated that a resolution was not needed.

Vice Mayor Caraballo moved to authorize staff to participate in the County meeting to preserve rights and obtain party status if no agreement is made by October 12, 2023. Councilman Bonna seconded the motion, which

passed unanimously by voice vote.
