The Assistant City Clerk read Ordinance 21-42 aloud by title only and Mayor Oravec opened the Public Hearing.

Laura Dodd, Planner II, stated that the applicant was proposing to amend the Future Land Use designation for 3.75-acres from CG/I (General Commercial/Institutional) to CS (Service Commercial). The

property is located in the SLW Development District located at the SW corner of NW University Boulevard and NW California Boulevard.

Ms. Dodd stated that the Planning and Zoning Staff recommended approval of the proposed Small-Scale Future Land Use Map Amendment.

Brad Currie, Engineering Design and Construction, gave a brief overview and offered to answer any questions. Mayor Oravec inquired as to if the project had to go before the St. Lucie West Master Association for approval, to which Mr. Currie responded in the affirmative.

The Assistant City Clerk read Ordinance 21-43 aloud by title only and Mayor Oravec opened the Public Hearing.

Patti Tobin, Long-Range Planning Administrator, stated that the request was to amend the Future Land Use designation for 4.6-acres from Residential, Office, Institutional (ROI) to Residential, Low Density (RL) and that the purpose of the request was to allow for the property (17 lots) to be consistent with the zoning of RS-2 and allow for the existing structures to be consider conforming and to allow the future development as single-family residences on the vacant lots, not owned by the City. One lot owned by the City has a Professional (P) Zoning District that will be changed at a later date. Ms. Tobin stated that the request was consistent with the Policies of the Comprehensive Plan, as

it related to Single-Family Residential.

Ms. Tobin stated that the Planning and Zoning Board unanimously recommended approval of the Small-Scale Future Land Use Map Amendment from Residential, Office, Institutional (ROI) to Residential, Low Density (RL) at their April 6, 2021 meeting.

There being no further discussion, the Public Hearing was closed. Vice Mayor Martin moved to approve Ordinance 21-43. Councilwoman Caraballo seconded the motion. The Assistant City Clerk restated the motion as follows: for approval of Ordinance 21-43. The motion passed unanimously by roll call vote.

**10. First Reading of Ordinances**

- 10.a** Ordinance 21-44, Authorizing the Issuance of Utility Revenue Bonds not to exceed \$37,000,000 for Various Infrastructure Improvements and Amending and Supplementing Ordinance 94-29

The Assistant City Clerk read Ordinance 21-44 aloud by title only.

Brad Macek, Utility System Director, gave a presentation which included a brief history of the Utility Revenue Bonds. (Clerk's Note: A PowerPoint was shown at this time.)

Councilwoman Caraballo stated that she was concerned with the rising costs in goods and asked if there was a contingency built in to ensure the cost of items, to which Mr. Macek responded that they have taken that into consideration and they have already seen prices increase.

Jay Glover, PFM Financial Advisors, LLC., stated that they were planning to structure the financing with a 30-year repayment with level debt service payments each year. Mr. Glover stated that they were in early discussions with the credit rating agencies and as part of the financing they will be seeking underlying credit ratings from S&P and Fitch.

There being no further discussion, Vice Mayor Martin moved to approve Ordinance 21-44. Councilwoman Caraballo seconded the motion, which passed unanimously by voice vote.



- 10.b** Ordinance 21-45, An Ordinance to Rezone Approximately 3.75-Acres from General Commercial (CG) Zoning Classification to Planned Unit Development (PUD) Zoning Classification for a Project Known as St. Lucie West - University Boulevard Business Center PUD (P20-160).

The Assistant City Clerk read Ordinance 21-45 aloud by title only.

Laura Dodd, Planner II, stated that the application was to change the zoning classification of the subject 3.75-acre property from CG (General Commercial) to PUD (Planned Unit Development) designation. She explained that the request was needed at this time to be compatible with the DRI Map H, permit buildout in SLW entitlements through a conversion matrix, update the reporting, and accommodate the future office/flex-space/warehousing uses proposed within the Applicant's PUD rezoning.

Ms. Dodd stated that the Planning and Zoning Board recommended approval of the proposed rezoning. The Site Plan Review Committee reviewed and recommended approval of the rezoning on September 23, 2020.

There being no discussion, Vice Mayor Martin moved to approve Ordinance 21-45. Councilwoman Caraballo seconded the motion, which passed unanimously by voice vote.

## 11. Resolutions

The City Attorney read the Quasi-Judicial Procedures into the record and stated that they pertained to Item 11 a). The Assistant City Clerk administered the Oath of Testimony to staff and other interested parties and read Resolution 21-R39 aloud by title only. Mayor Oravec opened the Public Hearing and asked if there were any ex-parte communications, to which there were none.

Laura Dodd, Planner II, stated that the applicant was proposing to amend the St. Lucie West (SLW) Development of Regional Impact

(DRI) Development Order text and map. Ms. Dodd gave a brief background and explained that St. Lucie West is an approved Development of Regional Impact (DRI) that consisted of approximately 4,614 acres. The St. Lucie West Development of Regional Impact (DRI) was approved by the City Council on April 9, 1987 through Resolution 87-R15. She added that there have been seventeen amendments to the St. Lucie West DRI.

Ms. Dodd stated that Text Amendment included a Conversion Matrix to accommodate buildout of the SLW DRI through equivalency, Biennial Reporting, and a Build Out. She added that the Map Amendment accommodated the proposed Future Land Use changes to Map H. Ms. Dodd stated that the incorporation of the Conversion Matrix does not create a reasonable likelihood of additional regional impacts. Ms. Dodd stated that the Traffic Impact Analysis was found to be consistent with the Comprehensive Plan.

Ms. Dodd stated that the Planning and Zoning Board recommended approval of the proposed DRI amendment at their meeting of April 6, 2021.

Brad Currie, Engineering Design and Construction, gave a brief overview and stated that to change the lane use within the DRI it required Map H. He added that the Matrix would allow the ability to have different lane uses without amending the DRI each time. Mr. Currie offered to answer any questions.

There being no further discussion the Public Hearing was closed. Councilwoman Caraballo moved to approve Resolution 21-R39. Vice Mayor Martin seconded the motion. The Assistant City Clerk restated the motion as follows: for approval of Resolution 21-R39. The motion passed unanimously by roll call vote.

## 13. New Business

- 13.a** Approve Major Site Plan for Project Senior in Southern Grove (P21-057)

Bridget Kean, Senior Planner, stated that the request was for a site plan approval for a 220,822 square foot warehouse delivery and distribution facility to be located on Lot 5, Southern Grove Plat No. 35. Ms. Kean stated that Kimley Horn and Associates and Culpepper and Terpening, Inc. are acting as the agents for Port St. Lucie Governmental Finance Corporation (GFC) (Owner) and that there was a Purchase and Sale Agreement pending between the GFC and JDN Enterprises, LLC (Sansone Group). Ms. Kean added that a traffic Signal at the intersection of Paar Road and Village Parkway would be provided with the Plat No. 35 submittal (P21-059).

Ms. Kean stated that the Site Plan Review Committee recommended approval of the Site Plan at their meeting on April 14, 2021 and that the Planning and Zoning Department staff found the request to be consistent with the direction and intent of the City's Land Development Regulations and policies of the Comprehensive Plan and recommended approval with the following condition: An easement agreement is executed between the GFC and the future owner of Lot 5 for the east-west driveways along SW Village Parkway prior to the issuance of any building permits for construction of the facility.

There being no discussion, Vice Mayor Martin moved to approve Item 13 a), with the recommended condition. Councilman Pickett seconded the motion, which passed unanimously by voice vote.

## 14. City Manager's Report

The City Manager stated that the Governor ended local Ordinances that restricted or opposed mask requirements. He stated that the City has been holding at least one Vaccination site per week.
