RESOLUTION 25-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, RELATING TO DRAW DOWN OF FUNDS FOR CONSTRUCTION OF INCOMPLETE INFRASTRUCTURE FOR RIVER PLACE ON THE ST. LUCIE NO 10 1ST REPLAT; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, River Place Builders, LLC ("Developer") provided an Irrevocable Letter of Credit ("LOC") as a surety for infrastructure associated with the River Place on the St. Lucie No. 10 1st Replat, as recorded in Plat Book 77, Pages 1 through 3, of the Public Records of St. Lucie County, Florida in order to secure required improvements outlined in the Completion Contract with the City dated April 30, 2018; and

WHEREAS, the Developer failed to complete pavement repair, final pavement, and striping ("Remaining Improvements") as provided in the Engineer's Certification attached hereto as **Exhibit "A"**; and

WHEREAS, the Developer desires for the City to draw down on the LOC; and

WHEREAS, the City Council approved Resolution 24-R91 to allow the draw down of funds from the LOC for construction of the Remaining Improvements; and

WHEREAS, the City Council approved Resolution 25-R23 allowing the execution of an Interlocal Agreement with River Place on the St. Lucie Community Development District (CDD) for use of the funds from the LOC draw down to complete the Remaining Improvements; and

WHEREAS, the City notified Seacoast National Bank, via certified mail dated January 13, 2025, to release the sum of Eighty-nine thousand nine hundred fifty dollars and no cents (\$89,950.00) from the LOC to complete the Remaining Improvements based on the contractor's cost estimate; and

WHEREAS, the Remaining Improvements were constructed by a contractor hired by the CDD and the final cost to compete the Remaining Improvements exceeded the previous estimate by fourteen thousand one hundred forty-five dollars and no cents (\$14,145.00) as evidenced by the change order attached as **Exhibit "B"**; and

WHEREAS, the City desires to request a supplemental draw down from the LOC to cover the additional cost to complete the Remaining Improvements; and

WHEREAS, the City Council resolves that all proceeds drawn under the LOC will be used solely for the completion of the Remaining Improvements required by the Completion Contract.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1.</u> <u>Ratification of Recitals.</u> The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

<u>Section 2.</u> <u>Implementation.</u> The City Manager, or his designee, are hereby authorized and directed to proceed to take any and all necessary actions, to draw funds from the Letter of Credit described above and execute all papers and other instruments required for that purpose.

<u>Section 3.</u> <u>Conflict.</u> If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 4.</u> <u>Severability.</u> The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
