The additional cost total is: \$24,174.56

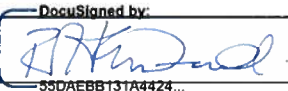

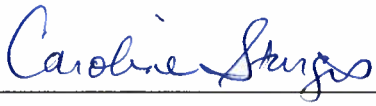
