A Regular & Virtual Meeting of the CITY COUNCIL of the City of Port St. Lucie was called to order by Mayor Martin on August 28, at 6:30 p.m., at Port St. Lucie City Hall, 121 SW Port St. Lucie Boulevard, Port St. Lucie, Florida & via Zoom.

5. Public to be Heard

Thomas Luce spoke about property tax increases, garbage pickup, and housing developers leaving a mess on his street.

Terry Melnicoff spoke regarding the importance of having defibrillators installed at the community parks.

Dodi Spence spoke regarding the Thornhill Lake/Floresta Project and questioned the \$26 Street lighting Assessment.

Olive McNaughton expressed concerns regarding her water bill amount, as it fluctuated from \$27 to \$236.

Redefine Church Members spoke regarding their contract with the Community Center and their use of a Haze Machine. (Clerk's Note: A script was provided for the record.)

Mayor Martin and Councilman Bonna responded to Mr. Lucy and explained the City's line items on the TRIM Notice.

Councilman Bonna: In regard to Redefine Church, I had a talk with the City Manager earlier today about this issue. To the extent, if we can accommodate you, I think we should. It is important to allow our residents to worship freely and it really hasn't been an issue for the past couple years, and I would defer to the City Attorney and the City Manager. If they really believe there's a health and safety issue, to make sure we are released from any liability that we might have, you know, to the extent, if we can make it work, let's go ahead and make it work. Thank you.

Vice Mayor Caraballo: As far as Mr. Hardison goes, I don't think it's a secret, but whenever we talk about the balance of risk in our facilities this isn't the first conversation we've had. I wholeheartedly believe in protecting the risks and ensuring that the City is safe and ensuring our property and infrastructure is safe, but also with the balance of ensuring those that want to utilize our facilities are able to utilize our facilities, and if a haze machine hasn't been an issue for 2 years and hasn't set off a fire alarm. . . .You know, I think we might need to revisit if it is something that we should continue to exclude or keep people from using if they so choose to. I do have concerns, Mr. Manager, in regard to the tone that was used in those emails. I would hope that our staff wouldn't speak. . . .I'm hoping there is more context missing. I am concerned with the directness and somewhat lack of customer service nature that I heard in some of those

quotations. Just so you know, we are not allowed to pop popcorn in the building because it can set off the fire alarm. We are not allowed to use candles in the building because it could set off a fire alarm. So, you know, I'm going with Councilman Bonna on this and I'm going to support what we can do, but I also, at the same time, need all the information in front of me to make sure that it is not a safety issue. I mean we have those restrictions as well, but if we can make it happen, let's make it happen. Thank you very much.

Councilman Pickett: I have a question for the church. Is the haze machine part of your worship or is it part of your production?

Mr. Hardison: I would say that it is one of the same. So, the production is part of the worship. It is merely a tool just so you can see the light in the room.

Councilman Pickett: I know what it is used for. I just want to know, is it a religious ritual that is used during your service? Or is it something that you use to promote the lighting?

Mr. Hardison: I would lean on the side of its used for production purposes. We could worship without it, but it certainly does serve a purpose to the worship as well.

Councilman Pickett: Ok, thank you.

Mayor Martin: As far as the haze machine, it is my understanding that this is an Administrative Policy. This is not a Council Policy. It is also my understanding that the reason why there are changes being made is because. . . just to be frank, there have been several policies in the past that have been outdated and there needed to be some changes to the way that the Community Center was being run for effectiveness and efficiency. And also, the reason why the change was made is because we are trying to keep consistent between all facilities in the City. So, Mid-Florida has the same policy and when the policies are being reviewed and changed because a lot of things are outdated. . . This is why this has come forward. For me, it's an Administrative Policy. The City Manager handles the Administration and so the City Manager and team decide on the best policy, in order to operate and maintain the buildings. That is my take on it. It is not a Council Policy. So, does anyone have anything else? Okay, we are going to move on.

The Deputy City Clerk read Ordinance 23-15 aloud by title only.

(Clerk's Note: A PowerPoint was shown at this time.) Bridget Kean, Senior Planner, stated that LTC Ranch was an approved Development of Regional Impact (DRI) that is approximately 2,445 acres in size. She explained that the entitlements included residential dwelling units & retail space on the west side, office & industrial space on the east side. She stated that the proposed amendment was to change 140 acres from Residential, Office, Institutional (ROI) to High Density Residential (RH) and to realign the adjacent segment of the proposed E/W #5 roadway to flatten out the curve.

Ms. Kean showed a location map, an aerial and a Future Land Use Map. She informed the City Council that FDOT recommended that the City address transportation needs that support a multimodal transportation system within the vicinity of the project when reviewing the site plan for the area & there were no comments from DEO or the other reviewing agencies. She added that there would be sidewalks and bike lanes on both sides of Wylder Parkway and a future bus stop in the vicinity. She stated that the Planning and Zoning Board and staff had recommended approval.

(Clerk's Note: A PowerPoint was shown at this time.) Steve Garrett, Lucido & Associates, provided a short presentation that gave some history on the site. Vice Mayor Caraballo inquired if the mitigation forced them to work with less space than previously expected, to which Mr. Garrett replied that they had two options and with the moving of the High School, it was determined to turn Pod A into a higher density, residential. Mayor Martin voiced concern over the new population straining areas like Tradition and St. Lucie West, to which Mr. Garrett replied that there were commercial properties surrounding Wylder. Mayor Martin stated that developers

needed to help the community more when it came to health, safety and welfare.

Kinan Husainy, Kimley Horn, stated that Wylder Parkway Phase I was open, Phase II should be cleared and graded soon, the widening of Midway Road was in discussions/applying for permits, and E/W #5 will be constructed with Pod 9.

Mayor Martin asked if there was anyone who wished to speak on the item. There being no one else to speak the Public Hearing closed.

Councilwoman Morgan moved to approve Ordinance 23-15, the motion died for lack of a second. Councilwoman Morgan stated that the existing allowable dwelling units 1,298 but they were proposing 1,100 and that is why she was in favor of it. She felt that houses had to be built prior to commercial properties.

Vice Mayor Caraballo moved to deny Ordinance 23-15. Councilman Pickett seconded the motion, which passed by roll call vote with Mayor Martin, Vice Mayor Caraballo, Councilman Pickett, Councilman Bonna voting in favor and Councilwoman Morgan voting against.

Mayor Martin opened for Public to Be Heard. Susan Cedeno spoke in opposition of the item due to traffic in the area. Vice Mayor Caraballo stated that she would not support this item as she felt that commercial was not right in that area, Councilman Bonna agreed.

Councilwoman Morgan stated that no meetings or workshops with the builders took place and therefore she requested that this item be tabled. She also requested a one on one meeting as well as a meeting with developers. Tersea Larno-Sarno, Deputy City Manager, stated that during the Developers Stakeholder meeting staff presented on the item. Colt Schwerdt, Assistant Public Works Director/City Engineer, stated that there was no formal process in contacting the developers but informal conversations took place with the majority of developers. He added that staff did their due diligence on the subject. Mayor Martin stated that the safety of residents was more important than the options of the developers and she would not support tabling the item. Vice Mayor Caraballo, Councilman Bonna and Councilman Pickett voiced why they would support the item.

Mayor Martin inquired if there was any ex-parte communication, to which the Vice Mayor Caraballo responded in the affirmative and the rest of the City Council responded in the negative.

(Clerk's Note: A PowerPoint was shown at this time.) Francis Forman, Planner II, stated that he had been sworn in and added that the official file was submitted to the City Clerk's Office 5 days before the meeting and requested that it be entered into the record. He explained that the applicant was requesting a Special Exception Use to allow for convenience store with fuel sales for a use totaling 6,396 square feet for a proposed Murphy USA gas station. He showed an aerial, the Conceptual Site Plan and explained the surrounding uses & the traffic analysis. He informed the City Council that the Planning & Zoning Board had recommended approval.

Brad Currie, Engineering, Design & Construction, stated that he had been sworn in. He agreed with staff's presentation and added that it was a redevelopment project.
