A RESOLUTION APPROVING AND ACCEPTING THE PRELIMINARY AND FINAL SUBDIVISION PLAT WITH CONSTRUCTION PLANS FOR VERANO SOUTH P.U.D. 1 POD C – PLAT NO. 2 (P19-005) WITHIN THE CITY OF PORT ST.
