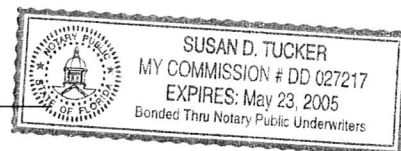

Exhibit "A"

Parcel 1:

A parcel of land lying in Section 31, Township 36 South, Range 40 East, St. Lucie County, Florida, being a portion of Parcel 3-B, as shown on the Plat of St. Lucie West Plat No. 36 - Acreage & Conservation Tracts, as recording Plat Book 30, Pages 1 and 1A-1U, Public Records of St. Lucie County, Florida, more particularly described as follows:

Beginning at the Southeast corner of the 3.02 acre tract conveyed to the Treasure Coast Christian Church as described in O.R. Book 691, Page 2561 of the Public Records of St. Lucie County, Florida; run thence North $15^{\circ}35'10''$ West with the East line of said tract a distance of 400.00 feet to a point at the Northeast corner of said Church Tract; run thence North $62^{\circ}52'37''$ East a distance of 200.00 feet to a point; run thence North $74^{\circ}24'50''$ East a distance of 109.95 feet to a point; run thence South $15^{\circ}35'10''$ East a distance of 440.00 feet to a point; run thence South $74^{\circ}24'50''$ West a distance of 305.91 feet to the Point of Beginning.

Parcel 2:

A parcel of land lying in Section 36, Township 36 South, Range 39 East, and in Section 31, Township 36 South, Range 40 East, all in St. Lucie County, Florida, particularly described as follows:

Commence at the intersection of the centerline of S.W. Flamingo Drive and the Easterly line of St. Lucie West Plat No. 2, Country Club Estates Phase 1, Parcel 8, as recorded in Plat Book 26, pages 9, 9A through 9G, Public records of St. Lucie County, Florida, thence run North 74 degrees 24 minutes 50 seconds East along the Northeasterly projection of the centerline of S.W. Flamingo Drive a distance of 446.67 feet; thence run North 15 degrees 35 minutes 10 seconds West a distance of 40.00 feet to the Point of Beginning; thence run South 74 degrees 24 minutes 50 seconds West a distance of 300.00 feet to a point of curvature; thence run Northwesterly along the arc of a curve, concave to the Northeast, with a radius of 25.00 feet and central angle of 92 degrees 51 minutes 25 seconds a distance of 40.52 feet to a point of compound curvature; thence run Northerly along the arc of a curve, concave to the East, with a radius of 1372.69 feet and a central angle of 20 degrees 03 minutes 28 seconds a distance of 480.54 feet; thence run South 82 degrees 40 minutes 17 seconds East a distance of 237.06 feet; thence run South 15 degrees 35 minutes 10 seconds East a distance of 400.00 feet to the Point of Beginning.
