Technical Proposal

Executive Summary

Since 1969 the Kauff's Group of Companies have provided services contemplated and demanded under the scope of the City of Port St. Lucie Citywide Towing Services. Independently we have provided like services to numerous Municipal, County, State, Federal agencies, Motor Clubs, Commercial enterprises and most importantly the Citizens of the State of Florida and its Guests.

From its beginning in Lake Park, Florida in 1969 the company has grown from a single truck providing services to a single motor club and the local community, to a full service, multi terminal Towing, Recovery and Specialized Transportation Company. With terminals in Dade, Palm Beach, Martin and St. Lucie Counties our fleet of specialty Towing, Recovery and Heavy Transportation Equipment have been the solution to the most complex Breakdown and Emergency situations 24/7/365.

In August of 2017 Kauffs merged operations with Crockett's Towing of Spring Hill, Florida and subsequently purchased the operating assets of Ace Towing of Orlando and Russell's Towing in St. Cloud. All entities are controlled by Guardian Fleet Services Inc., a Florida Based ESOP that continues to be owned by the former Kauffs and Crockett's owners. Both executive officers remain as president of the original companies and now as officers of the new parent Guardian Fleet Services Inc. In January of 2019, Guardian purchased an equity stake in the Professional Towing Group of Companies in Seffner, Florida with the owner Mark Kara maintaining his position of President and taking an executive position within Guardian Fleet Services, Inc.

One of the most important features of these mergers and acquisitions is the change to an ESOP. This change gives our employees an equity stake in the business through tenure programs. Making this change has effectively given tenured employees a long-term retirement program which is funded by overall company success. In short, this equity increases or decreases based on the overall job performance by every employee, every call, every day.

Combined the companies operate the largest fleet of Towing, Recovery and Specialized Transportation vehicles in the State of Florida. Our Heavy-Duty Fleet consists of forty-one Heavy Duty Wreckers including thirteen 50-ton fixed boom wreckers and thirteen Rotators ranging from 50-ton to 75-ton. Each of these wreckers are operated by well-trained and qualified Recovery Operators. We have independently, a total number of units and operators far in excess of the minimum requirements contained in this RFP, this allows us to provide immediate services to multiple events in any area needed, and if need be move an inspected and qualifying truck and operator from location to location in the event of a truck downed for unscheduled maintenance or monthly service.

Our location 8920 Glades Cut Off Rd, Port St Lucie was recently purchased by our owners, our location has 16 video and auto camera covering the whole location inside and outside. Our location has on site fuel so we are able to provide service no matter what weather situation we might encounter. Our location is staffed 24/7 by well trained and qualified wrecker operators, dispatchers with access to phone communication, digital communication OPS and camera tracking ability. Our location at 4701 East Ave, in West Palm Beach is our corporate headquarters and our main dispatch center. Completed in 2008 this facility is equipped with redundant communication abilities, an independent generator that

powers the entire facility and specially designed construction meeting the most recent requirement for Hurricane impacts. Our location is staffed 24/7 /365 by well trained and qualified wrecker operators, dispatchers with access to phone communication, digital communication OPS and camera tracking ability.

As a long-term service provider to all our local Law enforcement agencies, we recognize the value of partnering with well qualified, associated Towing and Recovery providers. We have learned to "Expect the Unexpected", whether it be the location of an incident, the service ability of a specific truck, or the availability of an operator. Our access to the largest number of qualifying trucks and operators in the entire treasure coast enables us to successfully meet our obligations and requirements under the terms of this RFP. Qualified operators that can be dispatched with their respective trucks from home after hours are the best solution for expedited service eliminating the need to travel to the tow yard and then back to the requested accident/impound location.

We have an extensive variety of towing equipment to handle any situation. Our equipment ranges from light duty wreckers, low-profile self-loaders, flatbeds, medium duty wreckers, heavy duty recovery wreckers and heavy-duty rotators, Landoll/Lowboy trailers along with paired tractors and fully equipped Rapid Incident Scene Clearance Trailer. All of this equipment allows us to recover and tow anything from a small job like a moped to a large job like a fire truck or rolled over tractor trailer. Together, our facilities have the capability to store over 500 vehicles at a time. In addition, we have indoor storage available for vehicles that must be investigated.

As founding member of the Towing and Recovery Association of America "TRAA", The Professional Wrecker Operators of Florida "PWOF" and more recently The Sunshine State Towing Association "SSTA" the Kauff's Group of Companies have continuously demonstrated our passionate commitment to Safe Practices and Training for all staff members and the associated workers they come in contact within the performance of their jobs. More importantly the safety of the consumer and the motoring public are dependent on our abilities and safety during any event. As founding members and officers of these fine organizations we advise on numerous issues regarding safety, education, training, representation and process improvements. Driver certification, OSHA workplace safety and compliance, Palm Beach Safety Council training, Miller Industries "Ring Leader" training, Traffic Incident Management and MOT training and certification are all imperative parts of our workplace training.

Our operational plan and use of additional qualified service providers demonstrates our clear understanding and our ongoing dedication and commitment to meeting the requirements, expectations and success of the citywide towing program

The Towing and Recovery Industry strives for technological advancement. Our dispatch center has a minimum of 2 dispatchers on site 24/7/365, allowing us to dedicate one dispatcher to any rotation call. Our qualified dispatchers not only use standard dispatch processes, but additionally have access to digital dispatch. Digital dispatch is a complex and new technology in our industry which allows our office staff access to our truck location via GPS, drivers hours with ELD device, and video from the multiple on-board truck cameras. As technology continues to grow within our industry we will continue to grow and

advance. There can and always be room for improvement and Kauffs Towing of Fort Pierce Inc., plans to stay on the forefront of implementation.

Philosophy and Understanding

With 50 years of providing service to the motoring public within the State of Florida, Kauffs Towing has continuously strives to meet the expectations of all parties we serve. Adaptation has allowed us to grow along with these communities. Due to the growing population of every community that the need for prompt expedited road clearance is more important than ever before. Our understanding of rotation services as requested by PSLPD is to provide Rapid Incident Scene Clearance of the city's roadways in a safe and efficient manner with qualified personnel and adequate equipment in order to maintain safe and clear roadways. This need is not based solely on the convenience of the transiting public, but rather for the safety of the traffic impacted by any road blockages, and the financial impact of the surrounding communities. The risk of secondary incidents and injuries to parties stopped or slowed down for any incident far exceed the initial impact from any rotation event. This quick and efficient cleanup helps to lessen and negate secondary accidents. Kauff's Towing understands the necessity of clear and concise communication between PSLPD, FTE, FHP, FDOT, and Rotation Contractors.

Chronologically, a sequence of events must take place for every response. The first line of contact during a rotation call must be a well-trained dispatcher with the ability to understand the specific location, direction of travel and general severity of the specific incident. This training must take place long before any activation or dispatch by PSLPD. Training prior to taking on the responsibilities within this RFP must include location and access points to specific areas of the city, education as to best location of qualified trucks, operators and support equipment.

As the contracted Rotation vendor, it is our belief that clear and concise communications is the basis of success in regards to each and every Rotation call. Proper communications expedites clearance of casualty vehicles and accident related debris. It is our responsibility to remove any accident related debris from roadways and grass areas.

It is the final obligation of the vendor to remove all vehicles and equipment under the control of the vendor along with all vehicles and debris from the roadway safely back to its respective storage facilities. The vehicles and information are to be available to all parties as they relate to PSLPD rotation guidelines. It is imperative that all parties work as one team to safely bring all events to completion.

Incident Management

Our goal is to provide expedited, safe Towing and Recovery service to PSLPD for Citywide Towing for all parties involved. Having detailed our overall understanding for successfully communicating our initial actions and preceding completion of each stage of any event we will now focus on the actual steps necessary to successfully complete any event. Success can only be defined as the safe completion of the removal and required clean up and remediation of all area's impacted by any rotation event within the times identified in this RFP. In order to comply with these requirements, we

have a large number of Trucks and Operators qualifying our endeavor to provide these services. For the purpose of quick and safe cleanup we have chosen to separate our Activations into multiple phases.

Activation Phase -During the Activation Phase, our dispatch center will take all details available from the dispatchers and notate all pertinent data. We will begin activating our essential equipment as required per call, including if needed; Flatbed, Rotator, 50-ton Recovery Truck, MOT, Truck/Trailer and Bobcat with attachments from Kauffs Towing. Our Dispatchers next step is to view the available traffic cameras and news outlets in order to relay additional information to our Operators, including but not limited to; additional equipment, accident details, and traffic. Our Dispatch will continue to update the PSLPD Dispatch on any changes to traffic flow or ETAs.

Assessment Phase -Once our operator arrives on scene, they will assess all vehicles and lane closures necessitated. We will take pictures of the scene if needed. At this point, we will determine the length of time the traveled portion of the roadway will be impacted. Our goal is to open the roadways as quickly, safely and efficiently as possible. With this goal in mind, our on-scene operator will coordinate with all Emergency Responders to determine if the activation is a "Move It or Work It" scenario. Should the operator believe that he can safely remove the blocking vehicle from the roadway without further incident and allow the traffic to move freely he can suggest to PSLPD and this can be expedited in a safe manor. With the approval of the PSLPD he can proceed to move the casualty to the side of the road.

Recovery Phase - Our on-scene our Operators will begin to recover the casualty vehicle. If roadways can be opened more efficiently by moving the unit(s) out of travel lanes prior to working the scene, then we will move it to shoulders or medians in order to reopen lanes. When moving the casualty vehicle before recovery would create an unsafe workspace or create an additional hazard, we will close additional lanes as needed. Time management is imperative during this phase and our dispatch and operator will continue to monitor our on-scene time compliance. We will continue to communicate with all Emergency Responders on any changes which may be necessary during the Recovery Phase.

Completion Phase - During this stage our Operator, will remove all debris Travel Lanes and Shoulders paying special attention to the impact of traffic and safety. All operators will continue to work with other on scene responders to verify roadways are ready for a complete lane opening. Upon approval of on scene PSLPD we will open all travel lanes. At no point will any debris be left on the travelled portion of the roadway or shoulders. Our Responders will determine with vehicle owners (when present) where the unit(s) are to be stored or delivered and will depart from the Scene.

After Action Review - All dispatch, supervisory, recovery and support personnel will have an after-action review within 48 hours. All involved personnel will discuss any complications that existed during the rotation and how to avoid such complications in the future. Supervisory pictures and video from our on-board cameras will be consulted during this phase. Our Operators will inspect all equipment used in recovery and will restock any equipment which was expended, depleted or damaged upon return to its respective yard.

Safety and MOT

All recovery participants in this proposal are 15B compliant; Kauff's Towing utilize a number of additional types of equipment on every scene to improve safety for all participants. Our Operators will always wear professional ANSI 3 apparel, steel toe shoes, hardhats, cut resistant Hi-Flex gloves, eye protection and additional Personal Protective Equipment. Our Heavy-Duty Trucks will be equipped with cameras which will record 360 degrees around our trucks during the incident. All trucks are equipped with GPS and ELD's for the ongoing tracking of every vehicle. Our MOT Team is constantly growing as we continue to train, educate and certify additional Operators and Support Staff in MOT courses. During any incident that requires our MOT, MOT Staff is equipped with one of our hands free 2-way radio headsets; this allows clear, concise communication between MOT and Operators on any apparent rotation. It is the position of MOT not only to keep our Operators safe, but to keep all vehicles passing aware of the risk of lane closures.

Management Team

Our management team plays an important role in every Rotation Activation and is the point of contact for any issues that may occur. They are responsible for communication, safety, training, scene supervision if needed. Our Management Team is the final arbiter for any decisions. Our Safety and Training Director is in charge of employee training and certifications. The dispatchers can be contacted by PSLPD for any additional communication issues. MOT Operators will oversee the Maintenance of Traffic of all Incident Scenes when needed.

Personnel Experience, Training & Certifications

With over 300 dedicated Towing, Recovery and Specialized Transportation Professional's through the State of Florida, Kauff's parent Guardian Fleet services offers a wide scope of equipment, training and personnel benefits to all personnel. All employees are paid hourly in accordance with Federal and State Wage and hour laws. They are entitled to a paid bonus if the revenues completed exceed a preset standard agreed to by all employees. As approximately 20% of all police activated tows are not redeemed and paid for by the registered owner, operators that are paid solely on a commission basis are often paid minimum wage by their employers. All employees are entitled to annual vacations with one week paid after one year, two weeks after 3 years and three weeks after 10 years. We offers a comprehensive medical package after 90 days inclusive of vision and dental and the company pays 75% of the single and 50% of any combination of Spouse or dependents. As previously mentioned, the employees as a group own 30% of Guardian Fleet Services Inc. and are awarded independently valued and federally regulated share on an annual basis. The shares vest over a controlled and established period of time making a significant retirement opportunity for every employee should he or she leave the stock within the ESOP. It is equally important to understand that these shares are funded by the income of the company and at no time are the employees financially responsible for any contribution to the ESOP plan. Certainly, one of the best examples and success of an ESOP is Florida based grocery chain Publix. The specific employee's involvement in the successful completion of each and every service provided has a recognizable value to every share opened by every party. The structure of the ESOP

assures to ongoing operation of any business as the business is no longer totally controlled by one individual or family. If something catastrophic was to occur and the owner was no longer able or willing to continue in the business, the business as often happens in this industry simply would close or be liquidated. With all parties dependent on the ongoing success in meeting each other's goals, the direct benefit and involvement in all segments of the business assures an employment environment not normally afforded other employer, employee relationships in this industry.

Training and Safety-Having 50 years of ongoing experience in the Towing and Recovery Industry the Kauffs Group of Companies has always prided itself of being the immediate solution to any event. As a founding member of the TRAA, PWOFF and SSTA, the Kauffs management team has been involved in setting curriculum and standards for all of these organizations as to best practices with specific attention given to safety to all parties involved in every incident. Special attention will be given to the assurance that all participants will be versed in OSHA rules and regulations and all participants will be out fitted with all safety apparel, Helmets, gloves, eye ware, vests, pants and shirts and allowed an annual work boot allowance for steel toed boots. In conjunction with our current insurance carrier we have developed an ongoing training and safety program for all operators and drivers for all Kauffs vehicles. All drivers must be a minimum of 24 years of age with three years of clean driving. All employees are run for any criminal offense or infraction and all employees train or shadow long term lead hands or supervisors for a minimum of 3 weeks and are subject to constant and consistent review for a minimum of 90 days. All employees are paid during any and all training and the company pays for all fee's for certification and education without regard to tenure. We believe this to be an investment in the employee whose success and understanding of the requirements of their specific jobs is dependent on their clear understanding of each and every requirement and the successful completion of each and every task. Unfortunately, many competitors are either unable or unwilling to invest in their people; rather they want the employee to be fully trained and ready to start work at the employee's expense or a previous employer's expense. The operators and management required for the success of this RFP is for the most part tenured longer-term employees. It is our policy that we want the "Good the Bad and the Ugly" in order that we can all benefit from our success and learn from our mistakes. We have weekly safety and training meeting with all drivers and operators usually on a Wednesday morning. At these meeting we review past incidents, review customer comments and discuss changing protocols. The company has employed a Safety Director since 2004. In the fall of 2017 our long term safety director and former FHP traffic homicide director retired. It was with his recommendation and willingness to train a new director the Mark Zook a recently retired FHP Traffic Homicide Investigator was hired. He is based in our Pt. St Lucie terminal but responsible for all Safety, TIM, MOT and OSHA training updates. Diana Turner located in our Tampa Facilities is responsible for our DOT Compliance and works directly with our insurance carrier on its training, safety and driver protocols. The company has in past offered support, heavy lift and recovery training to several Fire Departments and Municipal Agencies. The company has worked in conjunction and at the direction of the attending Fire Rescue Crew in the extraction of accident victims both living and deceased. The company is currently working with its local Fire Rescue Agencies in developing common goals, training and understanding in the availability and capabilities of our well trained and well-equipped Heavy Duty and Ultra Heavy Duty Trucks and Operators. Our review

of this RFP and our past involvement and performance lead us to adapting a proactive identification of best operators, equipment and station 24/7.

Equipment Capabilities & Quality Assurance

All Kauffs Towing operators are required to perform a daily truck inspection. We maintain records of these daily inspection logs. These inspections are routinely performed by our Wrecker Operators before they operate any vehicle. The daily inspection covers all parts of the unit including; electrical systems, hydraulic systems, pneumatic systems, mechanical components, winching systems, securement tools and all safety related equipment. Identification of any maintenance item that does not impact the safe operation of the vehicle is scheduled by each terminals service department. Regular preventive maintenance "PMs" are scheduled on either predetermined mileage or hours of service perimeters. All non-warranty repairs are performed in a Kauffs or Guardian repair center under the supervision or directly by an ANSI certified technician located and employed in the specific terminal. With 50 years of experience in recovering numerous pieces of equipment, vehicles and aircraft we have learned to "Expect the Unexpected". Kauffs and its well tenured mechanics understand and look for material failures prior to the total failure of any component. A key component to this RFP is the availability of qualifying backup equipment and personnel.

Geoff Russell the President of The Kauffs Group of Companies and CEO of Guardian Fleet has 35 years of experience with Miller Industries and its subsidiaries as President of Miller Industries Distributing, the retail sales division for Miller, VP of Operations for Road One, a national consolidator of Towing and Recovery Operators for 1996 through 2003 and VP of Operations for Century Wrecker Corporation. His experience as Plant Manager and relationship with many of the Nation's top equipment distributors, truck and component manufactures allows for a unique prospective as to problems and solutions on all aspects of wrecker operation and ownership.

As indicated in our executive summary Guardian Fleet Services controls and owns the largest fleet of Wreckers and Specialized Tractors in the South Eastern United States. Our ability to move qualifying and inspected trucks, wreckers and equipment from terminal to terminal, assures 100% availability to any Citywide towing contract. Support equipment, tools, accessories, skid steer loaders, sweepers are replaced on an as needed basis usually paying special attention to the serviceability of the components on each machine.

We have chosen to purchase a roll off truck and additional roll off 20-yard cans. Our immediate control and ownership of this equipment will expedite the availability in areas at the extreme end of any rotation. In addition, rough terrain forklifts "Telehandlers" have been added to our South Florida and Tampa Equipment lists. These units have the ability to drive off road and have long reach capabilities required to expedite the off and reloading trailers on the side of the road. Additionally, the company owns two large rubber-tired loaders available from our yard. The control and availability of this type of equipment will expedite removal of all debris, freight and burned vehicles.

Facilities Location

All facilities used by Kauff's in conjunction are owned and controlled by the officers of the company with the exception of our Stuart Location. This facility has been leased from BA Properties for the last 24 years. All facilities meet the criteria as dictated by this RFP rule 15b and are licensed in their respective municipality and county. Kauff's Towing of Fort Pierce Inc. operates at 8920 Glades Cut Off Rd. Port St Lucie, Florida 34986 in a 7,600 sq. ft. building. The outside storage location is 2.64 acres, paved and secured by chain link fencing. This administration, dispatch and vehicle administration center is ADA compliant, self-contained wash bay with hazardous waste recycle pit, 2 extra-large bays. Our Redundant communication ability allows us to dispatch to any Guardian facility within the state. In addition, our facility is equipped with HD video cameras covering the property. The cameras record 24/7 and all footage is stored via a Video Surveillance system. Our office staff has access to real time camera viewing via televisions located in the office. Onsite fuel tanks keep our operations running in any weather. For quick responses our drivers take their wreckers home with them at night and on weekends.

Dispatch & Response Capabilities

Kauffs Towing, Inc., are staffed by an on-site dispatchers 24 hours a day, 7 days a week. We never use a third-party call center. Dispatchers at Kauffs Towing, Inc. have access to all of our Wrecker Operators for any rotation activations. In addition, our office staff is trained and certified with Florida Department of Transportation which adds a level of knowledge for our call takers that very few in the industry can boast. Kauff's Towing use multiple platforms for communication between Dispatchers and Wrecker Operators. Our Dispatchers have access to Vehicle Tracking Software enabling our Wreckers to be monitored consistently in real time format.
