ct: Request purchase of CNT van through forfeiture funds

The Port Saint Lucie Police Department's Crisis Negotiation Team (CNT) currently has no reliable response vehicle. In the past the CNT has shared the Mobile Command Post platform to operate their specialty equipment and response from. However, due to numerous issues with the Command Post (wood rot, broken brackets, loose generator) to name a few, the police departments command post is out of operation. The Command Post was equipped with specialty wiring which allowed the CNT group to utilize their equipment inside the vehicle but, they have no back up platform. We are requesting that the Crises Negotiation Team be allotted their own platform, a new T-250 van which would provide a reasonable and maintenance friendly vehicle. This would also isolate the CNT group and leave the Command Post to its original purpose as a command and control station.

The base price for a new T-250 High Roof Transit Van is \$27,900, we will also need to request \$20,000 to retrofit the vehicle with options and to reconfigure the interior with work stations and air conditioning. The total requested will be \$47,900, we are requesting that the funding be sourced from forfeiture. This would provide a long-term solution for the CNT group as well as the department.
