Code Specialist Rachel Knaggs, previously sworn, read the case presentation and staff's recommendation into the record. She presented the photos that were taken of the inspection showing the subject property and provided an explanation of her investigation findings.

The Special Magistrate inquired if the Respondent would be complying if she were to reinstate the State Certification, to which Ms. Knagg's responded in the affirmative.

The Deputy City Clerk swore in the Respondent, Felicia Porter. Ms. Porter provided her explanation regarding the case and advised the Special Magistrate that she and another client reside in her home as the second client had passed away.

The Special Magistrate asked the Respondent if it was possible that she would seek to be reinstated by the State of Florida as an Assisted Living Facility, to which she responded in the negative.

The Special Magistrate stated he did not find any wrongdoing or inappropriateness regarding the actions taken by Specialist Knaggs. He inquired if Ms. Porter would be complying based on her explanation, to which Specialist Knaggs responded in the affirmative and indicated it would have to be verified by the City.

Ms. Porter asked for an explanation of how she did not follow the law, to

which Special Magistrate Davis explained the definition of a Single-Family home in the City of Port St. Lucie.

The Special Magistrate found that proper notice was achieved, and that the property remained in violation. He accepted the City's Recommendation and required compliance by March 20, 2024. He explained to Ms. Porter that before March 20, 2024 she would need to allow the City to reinspect the property and verify the occupancy status and confirm there were only two unrelated people living in the home. The Special Magistrate extended the compliance date to March 20, 2024, if not in compliance by that date a fine in the amount of \$25/day would be due every day the violation continued, not to exceed \$2,500 along with the administrative cost of \$411.

The Special Magistrate noted that was the only case with a Respondent present.
