- 3. Purpose: To join in the State of Florida's cooperative agreement opportunity for participating in the Bank of America Procurement Card Program. This will provide the City a competitively bid program with a strong Procurement Card Rebate Program.

- 5. Duration: Initial period began January 5, 2016 and continues through January 4, 2021, with an optional five-year renewal to January 4, 2026.

Background: The City previously participated in the Hillsborough County Consortium which ended on September 30, 2019. The State of Florida program will provide the City with an active program which has been competitively bid.

Issues/Analysis: Staff has reviewed the state contract and determined that it meets the requirements of the City's Procurement Ordinance.

Financial Information: Bank of America will split the fees charged to the vendors with the City in the form of a rebate. By entering into the State's Cooperative Purchasing Agreement, the City will be entitled to the economy of scale for the rebate at a higher rate than is currently available under our now expired contract.
